	The Complainant submitted a Notarized Affidavit dated 07.08.2024, as per the last order of the Authority dated 20.06.2024, stating the details of deductions made by the Complainant alongwith reasons for such deductions from the total amount of Rs.6,25,150/- paid by the Respondent.	
	Let the said Affidavit of the Complainant dated 07.08.2024 be taken on record.	
	Heard both the parties in detail.	
	The Complainant stated at the time of hearing that they have given a detail calculation of the total amount paid by the Respondent and the deductions which have been made by the Complainant from the said amount and it has been provided at page no.4 of the Affidavit of the Complainant dated 07.08.2024. Total Amount paid by the Respondent is Rs.6,25,150/- and the total deductions made by the Complainant is Rs.5,68,574/- and total refund made is Rs.56,576/. The total deduction of Rs.5,68,574/- contains the cancellation charge of Rs.4,43,000/- and GST on the cancellation charge at the rate of 18% which is Rs.79,740/- and GST on the demands raised by the Complainant but not paid by the Respondent, amounting to Rs.45,834/	
	Therefore, as per the Complainant, the Respondent shall get refund of Rs.45,834/- which is the GST Amount on two demands which have not been paid by the Respondent. The Complainant shall give all co-operation to the	

Respondent so that he get the refund of Rs.45,834/- from the GST Authority.

Complainant stated that they have already refunded Rs.56,576/- to the Respondent and Respondent stated that he has received the payment.

After hearing both the parties and taking into consideration the Affidavit of the Complainant dated 07.08.2024, the Authority is hereby pleased to direct the Complainant to provide all co-operation and necessary documents to the Respondent-Allottee so that he can get refund of the GST amount of Rs.45,834/-from the GST Authority at the earliest.
