- c) No more chance or time shall be given to the Respondent no.3A and 3B to file Reply / Rejoinder, if they fail to submit the same, as per the direction at (a) and (b) above, as per the provisions contained in section 29(4) of the Real Estate (Regulation and Development) Act, 2016.
