Heard the Respondent in detail.

The Respondent submitted a Supplementary Affidavit dated 31.07.2024 at the time of hearing today and Advocate of the Respondent stated that in their last Affidavit dated 24.07.2024, they have enclosed plans dated 19.09.2018 which was done by bonafide mistake on their part as the Junior Advocate who has prepared the Annexure do not have the knowledge of where the date of the plan is usually recorded.

A copy of the said letter is to be sent to KMC, alongwith this order; and
- b) The Respondent is hereby directed to send a copy of the Supplementary Affidavit dated 31.07.2024 to the Complainant, both in hard and scan copies, within **7 days** from the date of receipt of this order of the Authority through email; and
- c) Complainant is at liberty to file a Reply / Rejoinder against the said Supplementary Affidavit of the Respondent dated 31.07.2024 and send it to the Authority within **15 days** from the date of receipt of the said Affidavit from the Respondent, by post or by email, whichever is earlier.

The next date of hearing shall be notified in due course shortly.
