	The Complainant stated that she has received Rs.2,00,000/- as refund	
	from the Respondent till date.	

The Respondent submitted a **Refund Schedule** in its Affidavit at point no. 10 and he proposed that he will refund the Principal Amount in six (6) number of installments starting from July 2024 ending with December 2024.

Respondent also stated that they have paid Rs.2,00,000/- in the month of July 2024 to the Complainant.

The Complainant stated that she has no objection to take the refund of the remaining Principal Amount in six (6) installments if the refund is made alongwith statutory interest at the rate of SBI PLR+2% per annum as per the provisions of the RERA Act.

After hearing both the parties and taking into consideration the Affidavits placed on record, the Authority is hereby pleased to give the following directions:-

- a) The Respondent shall make refund of the balance Principal Amount of Rs.14,76,541/- (Rupees Fourteen Lakhs Seventy Six Thousand Five Hundred Forty One only) alongwith interest at the rate of SBI PLR+2% per annum, calculated on the Principal Amount paid by the Complainant, from the respective dates of payments made by the Complainant till the date of realization, in six (6) consecutive monthly installments starting from July, 2024 ending with December, 2024 and the payment shall be made by bank transfer to the bank account of the Complainant; and
- b) Complainant shall send her bank account details to the Respondent within 3 days from the date of receipt of this order of the Authority through email.

The Authority shall review the matter on next date of hearing. On the next date hearing shall be held through **online mode through zoom app** and hearing link shall be sent to both the parties accordingly.
