Extension of Floors (1) ----- 21.06.2024	<p>Whereas an Application dated 19.06.2024 has been submitted as per the provisions contained in section 14(2)(ii) of the Real Estate (Regulation and Development) Act, 2016 by the Applicant Promoter <b>Silverpeak Real Estate LLP</b> before the West Bengal Real Estate Regulatory Authority (WB RERA), for getting necessary approval for extension of the floor of the Real Estate Project namely '<b>Panihati Pride</b>' from <b>G+IV to G+VIII</b>.</p> <p>And Whereas the said project was registered under West Bengal Real Estate Regulatory Authority (WB RERA) with WB RERA Registration No. WB RERA/P/NOR/2023/000693 dated 31.10.2023. The validity of the Registration of the said project is going to be expired on 31.12.2024. As per the Applicant there will be no change in the completion date of the project due to the said extension of floors, as mentioned above.</p> <p>And Whereas a Meeting of the WB RERA Authority has been held today in the office of WB RERA and detailed discussion has been held regarding this matter and the Notarized Affidavit and relevant documents submitted by the Applicant have been examined thoroughly.</p> <p>And Whereas a Notarized Affidavit-cum-Declaration dated 18.06.2024 has been submitted by the Applicant herein, explaining the reasons for seeking extension of the floors of the instant project. He has stated in his Affidavit that he has neither sold any apartment nor invited any person to purchase any apartment in the said project. Therefore, there is no question of taking prior written consent of two-third allottees for the extension of floors of the instant project as per section 14(2)(ii) of the RERA Act.</p> <p>The Applicant also stated that the sanctioned plan of the instant project has been revised by the Competent Authority from G+IV to G+VIII.</p>	

And Whereas, after careful examination of the Notarized Affidavit and supporting documents on Affidavit, submitted by the Applicant and placed on record, this Authority is of the considered view that the Applicant Promoter has stated in his Affidavit that he has neither sold any apartment nor invited any person to purchase any apartment in the said project, therefore, there is no question of taking prior written consent of two-third allottees for the extension of floors of the instant project as per section 14(2)(ii) of the RERA Act. Hence, necessary approval can be given for extension of floors **from G+IV to G+VIII** and necessary update and alteration to be made in the WBRERA website where the details of the project has been uploaded by the Applicant at the time of registration of the said project with WBRERA Authority. This approval for extension of floors is urgently required to safeguard the interest of the prospective Allottees/Home buyers in the said project and for completion of the said project, for obtaining the Completion Certificate from the Competent Authority and for handover process of the completed flats/units to the Allottees, within the completion date that is within **31.12.2024**;

Now Therefore, in exercise of the power conferred under section 14(2)(ii) of the Real Estate (Regulation and Development) Act, 2016, this Authority is hereby pleased to take the decision unanimously to grant the necessary approval for extension of the floors from **G+IV to G+VIII** of the instant project namely '**Panihati Pride**'.

Secretary, WBRERA is hereby directed to issue a System Generated Modified Registration Certificate of the instant project for Extension of floors from **G+IV to G+VIII**.
