Heard the Complainant in detail.

The Complainant booked a flat in the project 'Kingstown' of the promoter company Usashi Realstates Pvt. Ltd. The project was abandoned by the said Promoter Company. Thereafter, at the instance of the promoter company the allotment of the Complainant was transferred to the project named as 'Evanie Econest' of Evanie Infrastructure Pvt. Ltd (the present Respondent) which is a sister concern of Usashi Realstates Pvt. Ltd. Till date the Complainant has paid total Rs.8,87,000/- (Rupees Eight Lakhs Eighty Seven Thousand only) in this regard to the Respondent. Agreement for Sale in this respect was executed between the parties on 02.12.2019. As per the Agreement for Sale, the delivery of possession of the flat was scheduled to be given on either at the end of year 2020 or at the beginning of the year 2021. Respondent failed to deliver the possession of the flat as per the scheduled time stated in the Agreement for Sale.

The Complainant prayed before the Authority for relief of refund of the entire Principal Amount which was paid by him along with interest as per RERA Act and Rules.

After hearing the Complainant, the Authority is satisfied to admit this matter for further hearing and order.

The Complainant is directed to submit his total submission regarding his Complaint Petition on a Notarized Affidavit annexing therewith notary attested supporting documents, if any, and a signed copy of the Complaint Petition and send the original Affidavit to the Authority serving a copy of the same to the Respondent, both in hard and soft copies, within 21 days from the date of receipt of this order through email.

The Respondent is directed to submit his Written Response regarding the Complaint Petition on a Notarized Affidavit annexing therewith notary attested supporting documents, if any, and send the original to the Authority serving a copy of the same to the

Complainant, both in hard and soft copies, within 15 days from the date of receipt of the Affidavit of the Complainant.
