

- b) The Respondent shall start the payment as per the **Refund Schedule** submitted by them as per the direction given at (a) above; and
- c) The Respondent is hereby further directed to show cause on another Notarized Affidavit why a penalty of Rs.5,00,000/- (Rupees five lakhs) shall not be imposed upon the Respondent Company for non-compliance of the final order of this Authority dated 07.11.2023 till date and send the affidavit (in original) to the Authority.
