They were under the assumption that project registration with WBRERA is a pre-requisite only prior to any sales activities.</p> <p style="text-align: center;">After receiving the Show Cause Notice bearing no. 1188-RERA/2M-08/2023 dated 18.08.2023 from the Authority, the Promoter immediately spurred into action and diligently prepared and complied with the requisite documents for the project's registration with WBRERA and they will submit the application for registration to the WBERERA Authority as early as possible.</p> <p style="text-align: center;">The Authority is of the considered view that the non-compliance of section 3 of the Real Estate (Regulation and Development) Act, 2016 by the Promoter Company is due to an inadvertent oversight and mistake on their part.</p> <p style="text-align: center;">The Promoter Company is hereby directed to immediately apply for registration of the project named as 'Meenakesh Tower' with the WBRERA Authority within a period of 15 days</p>	

from the date of receipt of this order of the Authority by email.

As there is a violation/non-compliance on the part of the Company of Section 3 of the Real Estate (Regulation and Development) Act, 2016, therefore, the Authority is of the considered view that a penalty is required to be imposed on the said Promoter Company as per Section 59 of the Real Estate (Regulation and Development) Act, 2016.

Hence, a Penalty of **Rs.5,00,000/-(Rupees Five Lakhs Only)** is hereby imposed upon the Promoter Company and he is directed to pay the amount directly by bank transfer to the Account of the WBRERA, within **30 (Thirty)** days from the date of this receipt of this Order of the Authority through email.
