	And Whereas a Meeting of the WBRERA Authority has been held today at the chamber of Chairperson WBRERA and detailed discussion has been held regarding this matter and the Notarized Affidavit and relevant documents submitted by the Applicant have been examined thoroughly.	
	And Whereas a Notarized Affidavit-cum-Declarations dated 31.08.2024 has been submitted by the Applicant herein, explaining he reasons for seeking extension of the instant project. They have xplained the reasons for non-completion of the said project within	-

the validity period of the Registration of the said project and prayed for an extension upto 31.03.2026 to complete the said project and handover of the flats / units to the Allottees.

As per the Applicant-Promoter, inspite of their utmost effort, they could not complete the said project within the validity period of the registration of the project that is within 24.09.2024 due to unavoidable circumstances and unforeseen reasons for which the Applicant Promoter has not been able to complete the development works of the said project. The Applicant Promoter is hereby directed to apply in Form E in the website of WBRERA for extension of Registration of the project for a period from 25.09.2024 to 24.09.2025 by submission of twice the registration fee as per the provisions of RERA and WBRERA Rules.

Secretary, WBRERA is hereby directed to issue a System Generated Certificate for Extension of Registration of the said Project as per **Form F** of the West Bengal Real Estate (Regulation and Development) Rules, 2021, for a period of 12 (twelve) months from **25.09.2024** to **24.09.2025**;
