details of the covered car parking space booked by him and the payment made by him in this regard and what is the scheduled timeline within which the Respondent has to deliver possession of the said covered car parking space to the Complainant annexing therewith notary attested/self-attested copy of supporting documents and send the Affidavit (in original) to the Authority, serving a copy of the same to the Respondent, both in hard and soft copies, within **15** (**fifteen**) days from the date of receipt of this order of the Authority through email.

The Respondent is hereby directed to submit his Written Response on notarized affidavit regarding the Affidavit of the Complainant, annexing therewith notary attested/self attested copy of supporting documents, if any, and send the Affidavit (in original) to the Authority serving a copy of the same to the Complainant, both in hard and scan copies, within **15** (fifteen) days from the date of receipt of the Affidavit of the Complainant either by post or by email, whichever is earlier.

Inspite of above orders both the parties are at liberty to take initiative to amicably settle the matter by mutual discussion and if they arrive at a mutual settlement, they shall submit a **Joint Notarized Affidavit**, signed by both the parties, containing the terms and conditions of the mutual settlement and send the Affidavit (in original) to the Authority, both in hard and scan copies, before the next date of hearing.
