Complainant stated that he is agree with the Refund Schedule, submitted by the Respondent, mostly, only the balance of Rs.14,10,100 is requested by him to be paid in every consecutive month starting from November 2024 with an Amount of Rs.1,41,000 in every month.

A Draft of Rs.2,00,000/- with D.D. No. 039312 dated 06.08.2024 has been handed over to the Complainant by the Respondent at the time of hearing and the Complainant accepted the draft.

After hearing all the parties, the Authority is hereby pleased to give the following directions:-

- a) The Lake Town IC has been directed not to take any action at present as the Respondent has started paying in installments and the Complainant has consented to the proposal. In future, if situation demands, necessary direction shall be given to him.
- b) Respondent is hereby directed to make payment as per the Refund Schedule given by them in their Affidavit, only with the modification that Rs.1,41,000/- shall be paid by the Respondent in every consecutive month starting from November 2024.

The Authority shall take stringent action if the Respondent fails to comply the above stated orders.

The Authority shall Review the matter in the month of November.
