Sub : Lodging of FIR on report of CSO Thai Smile for Unruly Behaviour Passengers

It is intimated that an email (Copy enclosed) received today from Mr Narshimha Rao (Rajiv) Chief Security Officer Thai Smile Airways Company Limited intimating an incident that took place in BANGKOK on the taxiway on Bangkok-Kolkata flight no. WE313 on 26Dec. Details of the incident reported through email are as under-

Passenger Ahmed/Mohammed Hussain Mr holding Indian Passport Z4447675 Seated on 37C refused to follow Safety Rules during Safety Check by Crew. His seat was in Reclined Back position with passengers sitting behind.

During Safety Check, crew asked Passenger (37C) to return seatback to upright position during take-off. Passenger refused to follow the rules and said he has backache.

Crew politely requested him to follow the Safety Standard procedures and using the Safety Card, Crew explained to the passenger again. He still refused to follow Cabin Crew instructions.

Air Purser while doing final Safety Checks requested him again to bring the seat to upright position and explained to him in detail that during evacuation (In CASE) his seat will block passengers who are sitting behind and he cannot perform bracing position properly.

As the passenger was not willing to listen, Air Purser informed him that she will need to complain to the Captain, to which he said to go ahead and complain to Captain and insisted that he will not follow the rules. This attitude of passenger caused other passengers who were seated behind to start complaining to the passenger.

Meanwhile passenger seated on 41C (Mr Shaikh/Azharuddin IND PPT V2551191) came up to seat 37C to talk to him and started arguing and fighting with the passenger. He along with some other passengers started badly beating Passenger Ahmed/Mohammed Hussain Mr.

Air Purser informed Captain of the incident and as a result Captain delayed Take-Off. After few minutes both the passengers stopped fighting and calmed down. Crew ensured that all passengers returned to their original seats and sat down.

Captain was informed by Air Purser that situation was under control and the flight continued as Normal. Air Purser ensured that no Alcoholic Beverage was served to passengers who were involved in the scuffle throughout the flight. During the flight it was observed that there were no issues with the passengers and passenger seated on 37C followed Crew Instructions.

The Captain and Air Purser reviewed, evaluated and analysed on this incident after the passengers calmed down and situation was back to normal, Captain and Crew decided not to pursue and press this issue further. The flight took off from Bangkok airport and landed at NSCBI Airport, Kolkata at 0058 hrs on 27/12/2022.

Later, a video of the entire incident was also found circulating on social media platform Twitter.

In view of aforementioned, it is requested to lodge an FIR under relevant sections of IPC against Mr Shaikh/Azharuddin IND PPT V2551191 R/o- 4/2/H/2, Mominpore road, Ekbalpore, PIN- 700023, West Bengal for Unruly Behaviour in flight, endangering human life and personal safety of others as well as against Passenger Ahmed/Mohammed Hussain Mr holding Indian Passport Z4447675 r/o- Paschim Gopal nagar, Hojai, P.O- Gopalnagar, PIN- 782435 for unruly behavior in flight.
