Baguiati , under BMC Ward No. 9 wherein he had alleged that the said person are liable for the unauthorized construction in the premises at RAA-6, Raghunathpur Purbapara P.S. Baguiati , under BMC Ward No. 9 as stop order had already been issued by BMC over the said construction but he did not pay heed . On the basis of the written Baguiati P.S Case No. 68/2025 Dated - 01.02.2025 U/S 295/261A/279/289 of West Bengal Municipal Corporation Act-2006.

With reference to the above mentioned subject to inform you that on the basis of a complaint a departmental enquiry has been conducted and it was found that **G+ 5 Storied building** is almost completed at the subject premises at RAA-6, Raghunathpur, Purba Para,, P.S- Baguiati, Kol- 700 059 under ward no -09 of Bidhannagar Municipal Corporation.

It prime facie appeared that the construction is being done violating Building Rules.and not found in any sanction plan during visit time.

It is also learnt during inspection that Sri Surajit Saha, the developer is responsible for such unauthorized construction.

It is to be noted that A Stop order cum Notice was issued from our end vide Memo No- BMC/BPN/2024/IC/590 Dated- 05/06/2024 for the said construction.

Whereas it is further observed that constructional works are still going on in violation of the stop order issued from this Corporation.

I would therefore request you to take the cognizance of the aforesaid matter and start investigation as per provisions of West Bengal Municipal Corporation Act-2006 and BNS-2023.

This letter may be treated as FIR U/S 295,261A,279,289 of West Bengal Municipal Corporation Act-2006 and any other relevant Section of BNS-2023.
