BDN East PS Case No. 10/25, dt-01.02.2025 U/S 281/125(b) BNS: one Ratan Bandyopadhyay (aged 71 years), son of Late Harakanchan Banerjee, residing at B13/8, Karunamoyee Housing Estate, North 24 Parganas, Salt Lake, Sector-II, PS- BDN East, Kolkata 700091, came at Ps and lodged a written complaint against one bus (Registration No. WB 19J 3791) to the effect that while crossing the road near Karunamoyee More, his wife named Ms. Sakti Bandyopadhyay (aged 72 years) W/O Ratan Bandyopadhyay of B13/8, Karunamoyee Housing Estate, Sector-II, PS- BDN East, North 24 Parganas, Kolkata 700091 suddenly was strucked by a bus (Registration No. WB 19J 3791) that was approaching from Sector V and turning right towards Tank No. 9 without maintaining traffic rule and the bus recklessly ran over both her legs. As a result she got severe injury on her person and presently is undergoing medical treatment. Over this complaint a specific case has been registered at this PS, Vide BDN East PS Case No. 10/25, dt-01.02.2025 U/S 281/125(b) BNS.

Subject: Formal Complaint (against Vehicle no. **WB 19J 3791 and its driver**) Regarding a Road Accident Involving My Wife

Respected Sir,

I, Ratan Bandyopadhyay (aged 71 years), son of Late Harakanchan Banerjee, residing at B13/8, Karunamoyee Housing Estate, North 24 Parganas, Kolkata - 700091, wish to formally bring to your attention a grievous accident involving my wife, Ms. Sakti Bandyopadhyay (aged 72 years).

On **17th January 2025, at approximately 9:30 AM**, my wife had stepped out to buy vegetables from the market. While crossing the road near **Karunamoyee More**, she was suddenly struck by a bus (Registration No. **WB 19J 3791**) that was approaching from Sector V and turning right towards Tank No. 9. Instead of taking the designated route around the traffic island, the driver **took a diversion**, catching her off guard. Before she could react, the bus recklessly ran over both her legs.

She was immediately rushed to **Bidhannagar SD Hospital** with the help of local people and the police, where she received initial medical treatment. The same day, she was transferred to **Apollo Hospital** for advanced care, where she remains under treatment. The **Medico-Legal Case (MLC) report** has already been submitted to your police station. As of today, she is undergoing her **fourth major surgery** due to the severity of her injuries.

Due to the immense mental and emotional distress caused by this incident and our continuous involvement in her medical care, we were unable to file this complaint sooner. However, we now seek justice and request that **legal action be taken against the bus driver for his reckless and negligent driving**. We urge you to investigate the matter thoroughly and ensure that the responsible party is prosecuted under the law.

We request your prompt action in this regard. Kindly keep us informed about the progress of the investigation.
