The gist of the case is that on 01/02/2025 at 20:05 hrs received one written complaint from one namely Dharmendra Kumar Rai of Uniworld City, Vista-05/205 under Techno City PS against five persons namely Chottu Yadav Singh and 04 others to the effect that the complainant was shifting his house hold belongings from the above residency to another residency of that said apartment by one shifting company namely National Movers and packers and the 05 persons came there and starting packing. On 01/02/2025 at about 10:15 hrs when the complainant's wife asked about one of her handbags and they replied that they packed it, but when his wife opened the packing, and found that the bag was stolen from there. The bag was containing some gold ornaments of herself which were stolen by the above five persons. On the basis of fact, a case has been started having Techno City PS Case No- 20 Dt.-01/02/2025 U/S- 303(2) BNS has been started.
