On 01/02/2025 at 16:35 hrs received a written complaint from Essa Mallik S/O Lt. Jahan Ali Mallik, residing near Kirtipur 2 No Gram Panchayat, Chariberia (Khari Bari), PO Kamduni, PS Rajarhat, Kolkata 700135, North 24 Parganas against four persons namely 1 Jan Mohammad 2 Imran Molla S'O Saim Ali Molla, Yusuf Molla S/O Oli Molla, and Noor Hossain Molla S/O Oli Molla all residing near Kirtipur 2 No Gram Panchayat, Khariberia (Khari Bari), PO Kamduni, PS Rajarhat, Kolkata 700135, North 24 Parganas to the effect that he is under serious threat to life, attempt to grievous injury and illegal usurpation of his property by the allaeged persons. He reported that on 01/02/2025 Jan Mohammad, who sold the shop through a registered deed came along with three alleged persons and tried to forcefully evict him from his shop, the alleged persons physically assaulted him with sharp weapons and blunt objects causing injuries to the complainant. 

Subject: Formal Complaint for lodging FIR Regarding Attempt to Murder, Grievous Injury, and Ongoing Death Threats.

Respected Commissioner,

I, Essa Mallik s/o Late Jahan Ali Mallik, residing near Kirtipur 2 No Gram Panchayat, Khariberia (Khari Bari), PO Kamduni, PS Rajarhat, Kolkata 700135, North 24 Parganas, am writing to formally lodge a complaint regarding a heinous attempt to murder and grievous injury inflicted upon myself by a group of antisocial elements led by Jan Mohammad.

The incident occurred on 01 February 2025 at 09:15am near my son shop located at the above address.

Details of the Incident:

On the aforementioned date, Jan Mohammad, who sold the shop through a registered deed but now seeks to evict us illegally, orchestrated the attack. He brought a gang of chronic criminals, including Imran Molla (S/o Saim Ali Molla), Yusuf Molla (S/o Oli Molla), and Noor Hossain Molla (S/o Oli Molla), There residing are near Kirtipur 2 No Gram Panchayat, Khariberia (Khari Bari), PO Kamduni, PS Rajarhat, Kolkata 700135, North 24 Parganas to assault us with sharp weapons and blunt objects. While the attackers brutally targeted us, Jan Mohammad stood nearby, instructing the violence. His actions demonstrate a blatant disregard for the law and a calculated attempt to eliminate us to seize our property.

The attack resulted in:

Severe injuries to myself stab wounds, fractures, and lacerations.

Emergency medical treatment at Rajarhat Block Health Centre (medical reports attached).

Ongoing Threats:

Despite our critical condition, Jan Mohammad and his accomplices continue to issue death threats. They have repeatedly intimidated us in person, warning that they will "finish us" if we pursue legal action. This unchecked violence and coercion pose an imminent threat to our lives and demand urgent police intervention.

Legal Provisions Invoked:

I urge the police to register an FIR under the following stringent provisions of the Indian Penal Code (IPC) and Bharatiya Nyaya Sanhita (BNS), 2023:

IPC Section 307 (Attempt to murder) and BNS Section 110 (Attempt to murder with intent to kill).

IPC Section 326 (Voluntarily causing grievous hurt by dangerous weapons) and BNS Section 102 (Grievous hurt by lethal means).

IPC Section 34 (Acts done by several persons with common intention) and BNS Section 201 (Conspiracy to commit offenses).

IPC Section 506 (Criminal intimidation) and BNS Section 302 (Threats endangering life).

BNS Section 210 (Organized crime involving land/property grabbing).

BNS Section 211 (Abuse of power to commit offenses).

BNS Section 110

Urgent Requests:

Immediate Arrest: Detain Jan Mohammad and his accomplices to prevent further violence.

Comprehensive Investigation: Probe the conspiracy, including Jan Mohammad's role in orchestrating the attack and his attempts to grab our legally owned property.

Security Measures: Provide police protection to my family and me to avert further threats.

This incident violates our fundamental right to life under Article 21 of the Constitution. The ongoing threats exacerbate our vulnerability, and Jan Mohammad's assumption of "all the power of the law" to unleash violence must be addressed urgently. The perpetrators acted under Jan Mohammad's direct instruction, making

him equally liable for attempted murder and criminal intimidation. Jan Mohammad's criminal history and property disputes must be investigated as part of this case.

l am available for further statements and will provide all evidence, including medical reports, witness accounts, and the registered deed proving our Son legal ownership of the shop.

We remain hopeful that justice will prevail under your leadership.
