On 01.02.2025 at 21:40 hrs: one Saptarshi Gupta S/O- Subhasish Gupta of DA- 71, Salt Lake City, Sector 1, Kolkata- 64, PS- Bidhannagar North lodged a written complaint to the effect that on 12.11.2024 while the complainant clicked a link in Facebook and a person called him through Whats App and introduced himself as a financial advisor of Steady Edge Capital. He persuaded the complainant to invest money in the platform of Steady Edge Capital and as per his instructions complainant invest a total Rs. 16,77,754/- in several transactions through his HDFC Bank A/C- 50100297755758. Later on, he realized that he had been duped by the said person on the pretext of short term benefit. Over this Bidhannagar North PS Case No- 16/25 Dated- 01.02.2025 U/S- 316(2)/318(4) BNS has been registered.


