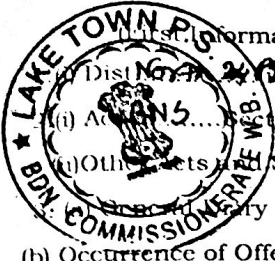

Sir,

With due respect I, Smt. Sneha Jalan, wife of Sri Deepak Tibrewal, daughter of Sri Sanjay Kumar Jalan, presently residing at 41, Golaghata Road, Khushboo Apartment, 1st Floor, Kolkata-700048 would like to inform you that I got married with Deepak Tibrewal on 21st February, 2023 as per the Hindu Rites and Customs. After my marriage I went at my matrimonial house which is situated at Swagat Garden, Narayantala WLN, Sharan Market, Chawalpatty, Block-C, 3rd Floor, Baguihati, P.S. Baguihati, Kolkata-700059 along with my husband to reside there as husband and wife with my in laws.

Thatafter a few days of my marriage my husband and mother in law namely, Smt Kanchan Tibrewal misbehaved with me on very trivial issues and abused me with filthy language without any reason. My mother in law always instigated my husband to inflict physical as well as mental torture upon me. She often humiliated me in front of my husband and she did not allow me to talk to any of the neighbour. While I mother in law humiliated me and abused me, my husband became indifferent and he also supported my mother in law.

It is pertinent to mention that at the time of marriage my parents gave me and my husband and in laws expensive gifts as per his capacity and also often gave me and my husband and in laws gifts on several occasions and festivals. My father gave an amount Rs. 1,00,000/- (approx.) to my husband and in laws as gifts. Though all the time my husband and mother in law received all the gifts but they did not satisfy with those gifts and always demanded more expensive gifts and money from my parents. If I tried to make them understand that my parents will not capable to remit their greed, my husband and mother in law became furious and threw abusive language at me.

My husband never gave me any expense for my daily needs. I with the help of my parents carried on my daily needs. Whenever I became ill, my husband sent me at my parental house as he would not want to take me to the Doctor and bought me medicines and told me to return at my matrimonial house when I will fit and fine. He even did not want to take any responsibility of mine. When he was at home he ignored me and never made any willful conversations with me. Most of the time he remained busy at phone and if I wanted to talk to him, he abused me with slang language.

Day by day the torture upon me by my husband and mother in law had been increased. They did not provide me sufficient food. I performed all the house hold work but was not provided sufficient food by my husband and mother in law. They always hurled slang language at me and wanted to oust me from my matrimonial house. For their daily physical as well as mental torture day by day my health condition started to deteriorate and I fainted frequently which was considered as drama by my husband and mother in law.

That on 08.11.24 my husband and mother in law abused me physically and mentally and compelled me to leave my matrimonial house in one cloth, keeping all my belongings and Stridhan Articles at my matrimonial house.

That finding no other alternative I took shelter in my parental house. During my stay at my parental house my husband and in laws never contact with me and my husband do not provide me any farthing for my daily expense. Whenever I or my parent call them over phone, my husband and in laws told my parents that they would contact with us soon. Due to that reason I became hopeful that I will stay at my matrimonial house happily with my husband and in laws.

But after lapse of so many days neither my husband nor my in laws contacted with me.

However, due to the hopes given by my husband and in laws that I will stay at my matrimonial house happily I waited for their response and did not lodged any complaint before you. Nowadays my sister in law namely, Urvashi Goel (Nanad) and her husband namely, Anand Goel are calling me over phone and asking me to prepare divorce petition and my husband will not provide me any farthing, he will only give me divorce and nothing else. Gradually I understood that my husband and in laws have exploited me physically and mentally and after snatching everything from me they behaved with me like a street dog and ousted me from my matrimonial house.

Under such circumstances, I lost all my hopes and as a helpless woman I, therefore, request you to look into the matter and take necessary stern action against my husband namely, Deepak Tibrewal and mother in law namely, Smt Kanchan Tibrewal according to the provision of law.
