The person in question, named KRISHNAGOPAL BANERJEE (Contact number : 8327018022) has been persistently stalking me on social media platforms, sending unsolicited emails, making fake profiles continuously. Despite my attempts to block or ignore him, his behavior has continued, leading to significant emotional distress and a feeling of being unsafe.

In addition to the online harassment, this individual has been showing up physically even at my residence more than a year and engaging in actions, that suggests he is monitoring my movements. I feel like being followed/watched and this has been causing a real mental stress and fear to me. He has started placing uncanny items and gifts at my gate (A-6/7 Kalindi Housing Estate, Kolkata - 700089), ringing the calling bell at odd times, which has escalated my fear for myself and my family's personal safety and well-being. I am deeply concerned that this behavior will continue to intensify if not addressed.

I kindly request that your department investigates this matter and take appropriate action. I trust that you will treat this matter with optimum seriousness and I absolutely look forward to cooperating with you for any further assistance.
