The fact of the Case in brief is that on 03.02.2025 at 15.05 hrs one Namrata Agarwal D/O Pawan Sanganageria W/O Vijay Kumar Agarwal of Ashoka Ratna Building, Flat No. 11/303, Shankarnagar, P.S. Mowa, District Raipur, Chhattishgarh PIN- 492007 A/P PS Magnum Block-3 Flat 3A, VIP Road, Kaikhali, P.S. Baguiati, District North 24- Parganas, Kolkata- 700052 came to this P.S. and submitted a written complaint against her husband (1) Vijay Kumar Agarwal S/O Nirmal Kumar Agarwal of 144/25, Dharmatala Road, Salkia Howrah P.S. Malipanchghora, District Howrah, PIN -711106 A/P PS Magnum Block-3 Flat 3A, VIP Road, Kaikhali, P.S. Baguiati, District North 24- Parganas, Kolkata- 700052 wherein she alleged that she got solemnized her marry on 25.02.2006 with said Vijay Kumar Agarwal accordingly to Hindu Rites after giving Gold Ornament, Household articles, Utensils and Cash as per demand. But since after her marriage she was subjected to torture both mentally and physically by her husband and lastly on 03.02.2025 at around 10.30 hrs her husband started to torture again over various issues and threatened with dire consequence. On the basis of the written complainant Baguiati P.S Case No. 74/2025 dated 03.02.2025 U/S 85/316(2)/351(2) BNS.

notice for mutual separation. I have
received his reply to our notice
today in which he raised question
about my conduct despite my full
dedication to my family. So it is
clear that he is still not apologetic
of his behaviour and therefore I shall
be proceeding for divorce. Meanwhile
my daughter Komari Varsha Agarwal
has her exam till 28.02.25. My
parents ~~live~~ live in Raipur, my husband
has his parental house at Sarkia,
Howrah. Due to ruckus created by
my husband yesterday and today my
daughter had nervous breakdown. Seeing
her situation I decided to leave my
home with my daughter, and when I
conveyed my decision to my husband
he left the house in the fit of
rage before me. He clearly stated
that I can stay in there and he

will not come back again.
I feel insecure with my husband
Mr Vijay Agarwal and now after
all this incidence, that both me
and my daughter ~~need~~ ^{need safety} ~~police~~
~~protection~~ from my husband, who

look into the matter and ensure
that he will not be harming us by
any means.

Further it would be great help
and great support if my husband
is asked or directed to stay
away from PS Magnum Block 3, Flat-3A.
Further I request authority to
help me in getting divorced and
alimony as I have my ~~da~~
daughter custody with me.
