The fact of the case is brief is that today on 02.02.25 one Abhishek Vishwakarma S/O- Rajesh Kumar of 4A Radhe Enclave, 53 Kamalapur West, Kolkata-700028. Came to PS and submitted a written complain to the effect that Today at 2nd February 2025 at about 11 a.m. the complainant's father Rajesh Kumar and his sister Aditi Vishwakarma riding a motorcycle bearing number WB 24 AB 5489 were going to attend a school function from Airport Inno to Siddha town towards Chinar Park, at that time a bus bearing number WB-25D-0933 of route L-238 Bus hit them from the back side of Motor Cycle, they fell down on Road. As a result the complainant father got serious injury and at presently he is admitted at Charnock Hospital ICU, and there motorcycle has been damaged very badly. Airport PS FIR No U/S 281/125(b)/324(4) BNS Dt: 02/02/25. The Case is started.

Sir,

I Abhishek Vishwakarma, s/of Rajesh Kumar
regret to inform you that today morning
2nd Feb 2025 at approximately 11:00 AM,
my sister Aditi Vishwakarma, with my father
was going to attend a school function from
1 No. Airport to Sidha Town towards Chinnar
park, got involved in a serious accident.

The accident area was near Airport Authority
of India gate A1. While going on bike number
WB 24 AB 5489 my father, and my sister got
suddenly hit by the bus from behind numbered
WB 25 D 0933, driver Avijit Ghosh at the time.

The accident caused critical injuries to my
father, resulting in him getting admitted to
Charnokk Hospital. ICU. By the time I
got to know about the incident, the
reports of CT scan showed that his
ribs got broken and damaged scapula, and
the motorcycle got severely damaged.

I would like for me to and my family
to get justice and the driver gets
punished accordingly.
