12. First Information contents (प्रथम सूचना तथ्य):

On 02/02/2025 received a written suo-moto complaint from SI Atanu Khamaru of Narayanpur PS to the effect that on 02.0.2025 at around 00:45 hrs the said SI received a credible source information that 02 Bangladeshi nationals, moving suspiciously around Airport PS area on way to shelter Donnagar Muslim residential Area. Accordingly, the officers and force held raid at Donnagar area and secure arrest of 02 accused persons namely (i) Md. Mokaieel (45 yrs) S/o Lt. Md. Siyamuiddin Molla of Golakhali, P.O- Vatkhal, PS Shyamnagar, District Satkhira, Bangladesh (ii) Sabuj Gazi (32 yrs) S/o Nabab Ali Gazi, of Kajla Indranagar P.O- Kajla Chak, P.S Kaligunj, District Satkhira, Bangladesh. On demand they failed to produce any valid documents for entering Indian Territory. It appears that there are some unknown agents who used to prepare false documents and help Bangladeshi nationals to enter Indian Territory illegally. On searching their persons, Indian Currency of Rs. 700/- was found and seized from their possession. Over this, started Narayanpur PS Case No. 25/25 Dt. 02.02.2025 U/S 14A Foreigners Act.

Sub: Prayer for lodging F.I.R.

Sir,

In producing here with two arrested Bangladeshi national namely (i) Md. Mokaiel (45 yrs) S/o Lt. Md. Siyamuddin Molla of Golakhali, P.O- Vatkali, PS Shyamnagar, District Satkhira, Bangladesh (ii) Sabuj Gazi (32 yrs) S/o Nabab Ali Gazi, of Kajla Indranagar P.O- Kajla Chak, P.S Kaligunj, District Satkhira Bangladesh with arrest Memo, seizure list, medical certificate. I, do hereby lodge a complaint against the aforesaid arrested persons to the effect that on today i.e. 01/02/2025 at around 00.45 hrs. received a credible source information that, two (02) suspected illegal Bangladeshi National are moving suspiciously around Airport PS area who have infiltrated into Indian territory illegally through Hingalgunj Border of Indian side supposed to come into Donnagar under Narayanpur PS area in search of shelter for their stay at the locality. If they sense any this suspicious they will flee away to Bangladesh again illegally from India side one of them may be a under trial prisoner of the Banladesh Govt. The suspected Bangladesh national who entered illegally has procured Indian identities fraudulently with the help of forged documents. Accordingly, the information is diarised and informed superiors accordingly vide GDE. No. 53 dated 02.02.25.

At about 00.55 hrs I along with SI Raja Saha, Const. 1079 Sajal Mandal, Const. 87 Sujit Jadab, Const. 783 Amar Das left for Donnagar under Narayanpur PS jurisdiction to work out the information as per your kind order vide GDE no. 54 dated 02/02/25 by Govt vehicle electronic investigation kits and gadgets and stationary accessories etc. At about 01:25 hrs. I along with other officer and force of Narayanpur PS along with the source arrived at Donnagar, Airport Authority of India boundary wall near Gangeswar temple to work out on the received information. We kept ourselves camouflaged. After a prolonged ambush at about 01.45 hrs our source identified the targeted persons who were coming suspiciously through Ramesh Mitra Road towards Gangeshwar Mandir crossing the border of Airport PS jurisdiction. Accordingly, our team cordoned and detained them at the said spot being pointed. We disclosed our identity to him and offered him to search ourselves which they refused. After a thorough interrogation; the detained persons disclosed their identity as noted above. The aforesaid arrested persons were also asked to produce documents (Passport and Visa etc.) in support of legal staying in India, in written but they failed to do so and repeatedly emphasized on the fact that, he is a Indian national. After a prolong interrogation they both admitted that they are actually Bangladeshi national and they absconded from there and entered illegally in Indian Territory through Hingalgunj Border of India side respectively. I also communicated him in written to use government telephone to contact his relatives or any familiar person who can bring/produce the legal documents, if any, but he declined to do so.

They also disclosed that, their Indian Identity Cards are already procured fraudulently through several touts to stay here legally in India to evade arrest by Indian

Police. After issuing notice to the detainee, I searched him and his personal belongings and found one mobile phone, wearing apparel and Rs 700 (INR) cash.

On interrogation, it came to light that the detained persons are looking for safe hiding place at Muslim community area today their logistics provider will come and arrange for their safe place to stay. Hence, they are arrested by me. Arrest Memo has been prepared. Thoroughly searched them and recovered one pc Rs 500/-, and 2 pcs Rs. 100/- notes in Indian currency from the possession of Md. Mokaiel (45 yrs) S/o Lt. Md. Siyamuddin Molla. As nothing was found from the possession of other arrested person NIL seizure list has been prepared.

The whole search and seizure procedure was video graphed as per legal norms. After communicating the reasons of arrest. I also described him grounds of arrest in written. Under this circumstance, I request your good self to start a specific case under section 14A of Foreigners Act, and arrange for its regular investigation.
