## Order No. 01 dated 28/06/2024

The Appeal is taken up for hearing on the point of admission.

We have heard Mr. Subhas Basu, learned Counsel for the Appellant.

Learned Counsel for the Appellant submits that though the impugned Order was passed on 30<sup>th</sup> January, 2024, but his client received the copy of the Order on 21<sup>st</sup> May, 2024. Learned Counsel points out that since the Appeal has been preferred within sixty days from the date of receipt of the Order from the learned West Bengal Regulatory Authority on 21<sup>st</sup> May, 2024, the Appeal has been preferred within time.

Section 44(2) of the Real Estate (Regulation and Development) Act, 2016 provides that every Appeal made under Sub-section (1) shall be preferred within a period of sixty days from the date on which a copy of the direction or Order or decision made by the Authority or Adjudicating Officer is received by the appropriate Government or the Competent Authority or the aggrieved person and it shall be in such form and accompanied by such fees, as may be prescribed.

From a photo copy of an Advocate's letter and from a print-out of a communication vide e-mail from the learned Regulatory Authority it appears that the Appellant received the copy of the impugned Order on 21<sup>st</sup> May, 2024.

Therefore, we find that the Appeal has been filed within time.

We have perused the impugned Order dated 30<sup>th</sup> January, 2024 passed by the learned West Bengal Real Estate Regulatory Authority in complaint No. WBRERA / COM000130.
