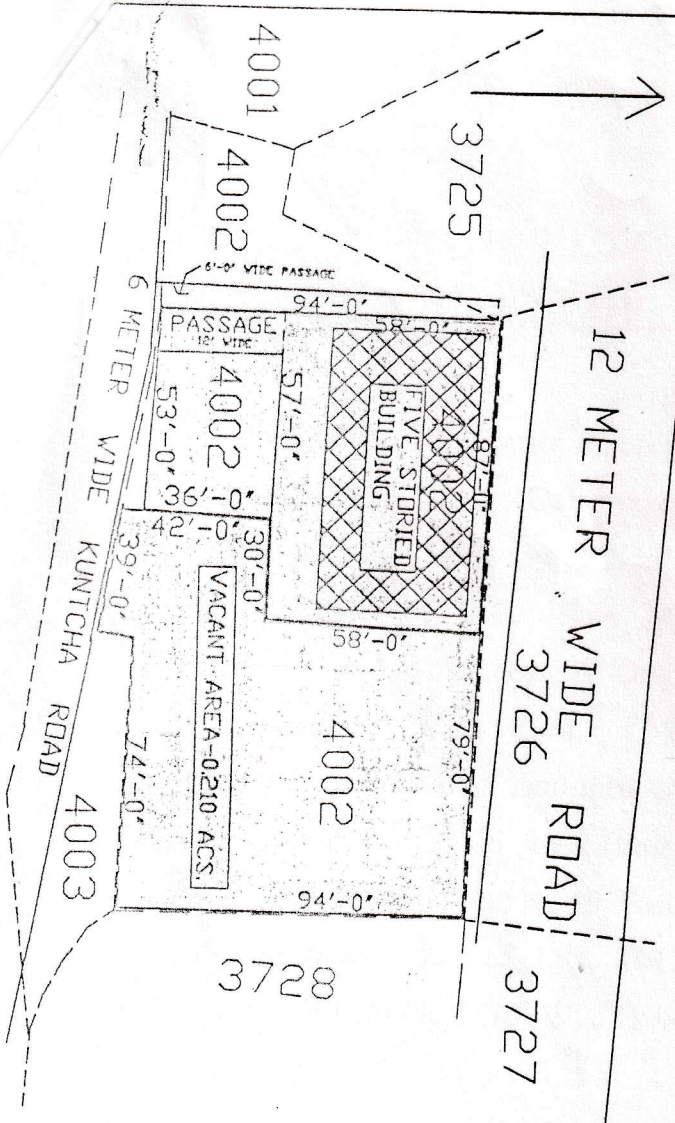
LAND AND STRUCTURE OF SMT.MINERVA BISWAS SHOWN THUS-
