1. Each quarter of Municipal Property Tax will be considered as per the financial year.
2. Rebate @5% of the property tax will be allowed if paid within the respective due dates.
3. Hardcopy of duplicate bill may be obtained from Assessment Department of Bidhannagar Municipal Corporation (Head Quarter) on payment of Rs. 50/- (Rupees fifty) only.
4. Property tax payment by Cheque/Draft in favour of '**Bidhannagar Municipal Corporation**' will be accepted, subject to realization. However in case of Cheque/Draft payment, the entire amount is to be paid by a single Cheque/Draft.
5. Payment of property tax can be made from **11am – 3pm** in any branch of HDFC Bank (Excluding Kestopur Branch, Kolkata-101) within Bidhannagar Municipal Corporation area.
6. If the cheque is dishonoured for whatsoever reasons, payment will be accepted only in cash and a clerical charge of Rs. 250/- (two hundred fifty) only per bill will be payable in addition to interest, if any.
7. Assessee No., Holding No., Bill No., Quarter No. and Contact No. should be clearly mentioned at the back side of the cheque (A/C Payee)/Draft.
8. Penalty and Interest against the due Municipal Property Tax, which may be decided by Bidhannagar Municipal Corporation will be binding on the assessee.
9. Cheque should be deposited at least 7(seven) working days before the due date for payment and/or rebate entitlement.
10. Payment of Property Tax can also be made **online** by visiting [www.bmcwbgov.in](http://www.bmcwbgov.in) on **through Debit/Credit cards**.
11. For any Property Tax related query, the Assessment Department of Bidhannagar Municipal Corporation may be contacted.
