- 1. Each quarter of Municipal Property Tax will be considered as per the financial year.
- 2. Rebate @5% of the property tax will be allowed if paid within the respective due dates.
- 3. Hardcopy of duplicate bill may be obtained from Assessment Department of Bidhannagar Municipal Corporation (Head Quarter) on payment of Rs. 50/- (Rupees fifty) only.
- 4. Property tax payment by Cheque/Draft in favour of 'Bidhannagar Municipal Corporation' will be accepted, subject to realization. However in case of Cheque/Draft payment, the entire amount is to be paid by a single Cheque/Draft.
- 5. Payment of property tax can be made from 11am 3pm in any branch of HDFC Bank (Excluding Kestopur Branch, Kolkata-101) within Bidhannagar Municipal Corporation area.
- 6. If the cheque is dishonoured for whatsoever reasons, payment will be accepted only in cash and a clerical charge of Rs. 250/- (two hundred fifty) only per bill will be payable in addition to interest, if any.
- 7. Assessee No., Holding No., Bill No., Quarter No. and Contact No. should be clearly mentioned at the back side of the cheque (A/C Payee)/Draft.
- 8. Penalty and Interest against the due Municipal Property Tax, which may be decided by Bidhannagar Municipal Corporation will be binding on the assessee.
- 9. Cheque should be deposited at least 7(seven) working days before the due date for payment and/or rebate entitlement.
- 10. Payment of Property Tax can also be made online by visiting <a href="www.bmcwbgov.in">www.bmcwbgov.in</a> on through Debit/Credit cards.
- 11. For any Property Tax related query, the Assessment Department of Bidhannagar Municipal Corporation may be contacted.
