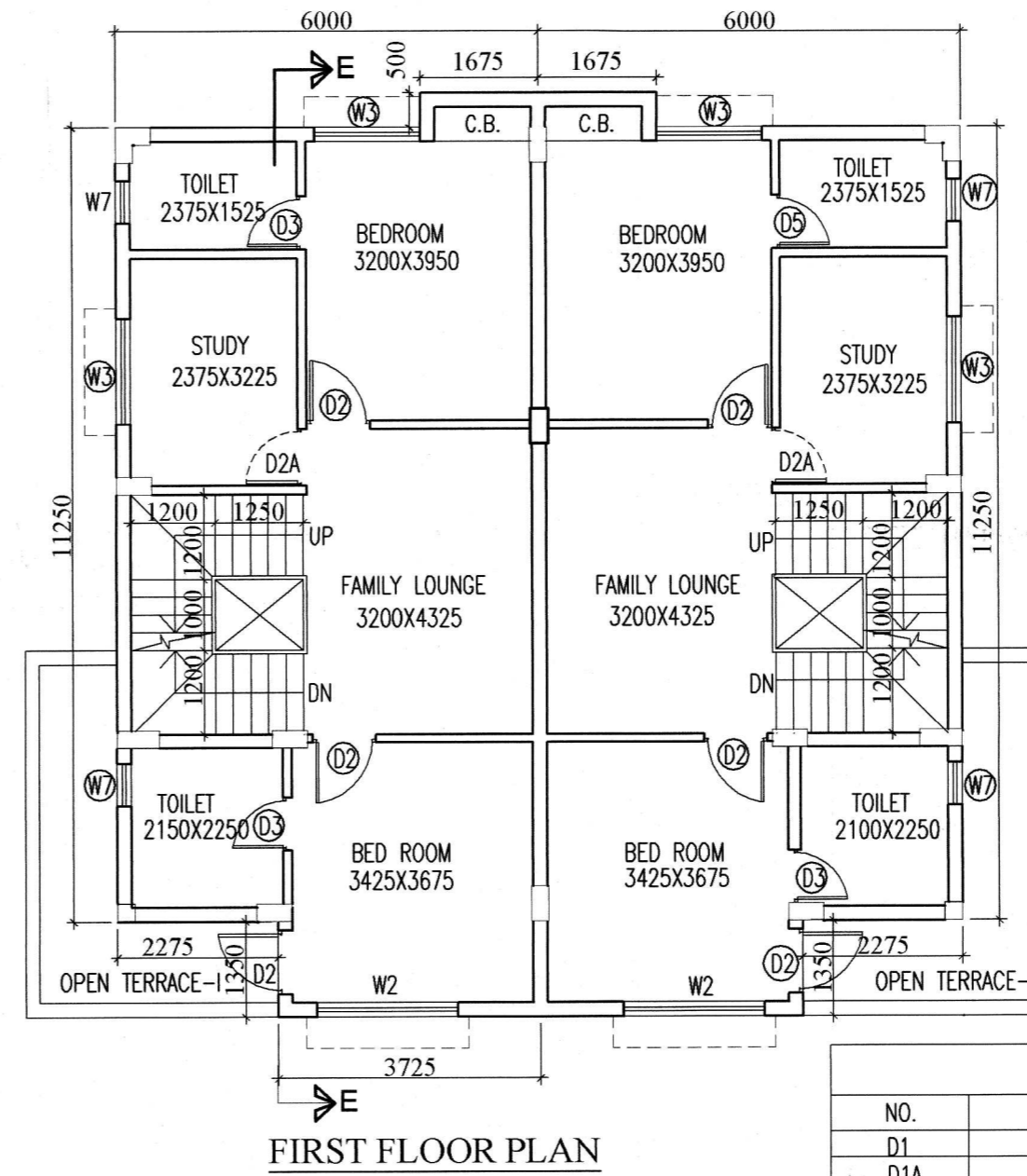
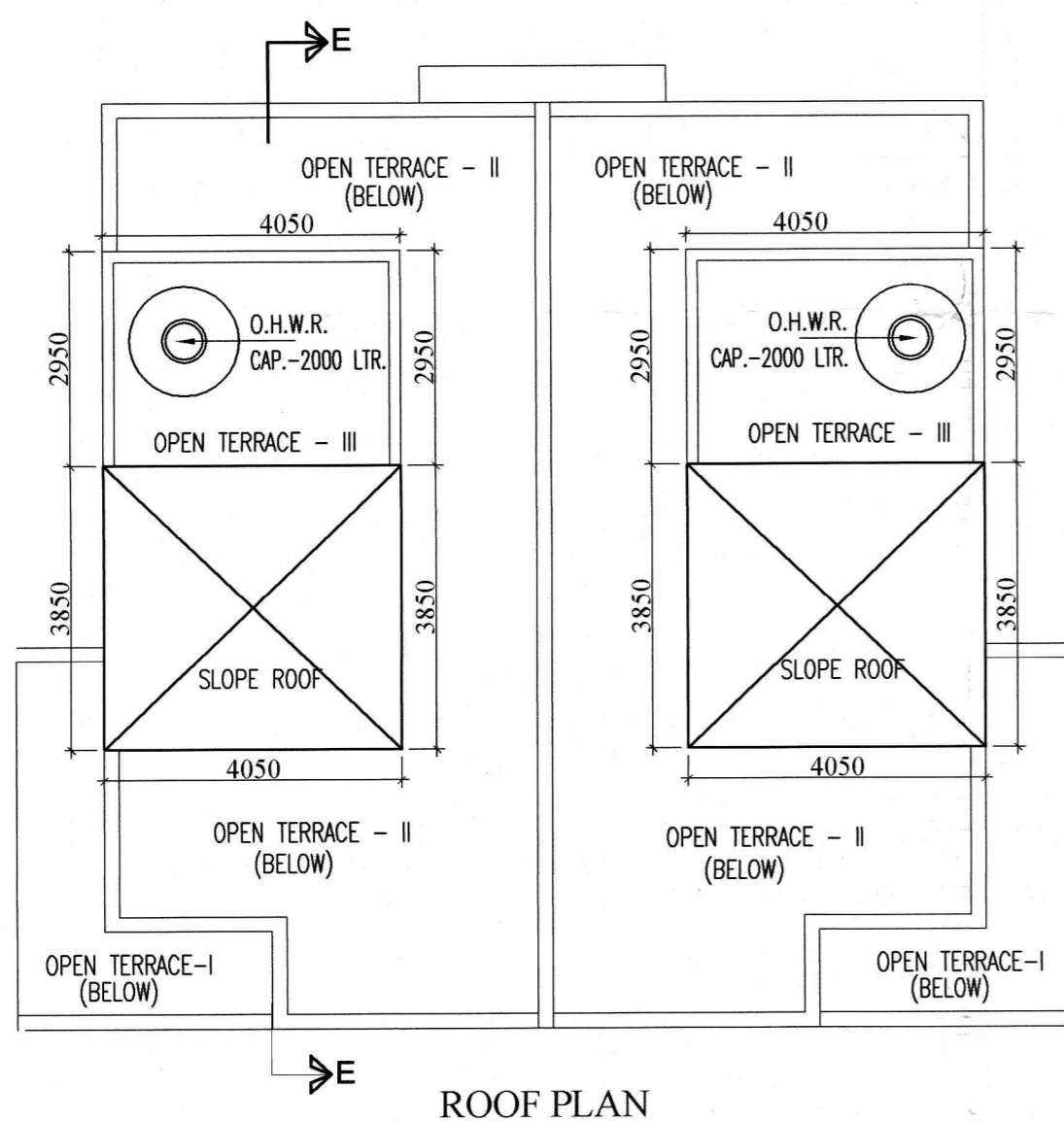


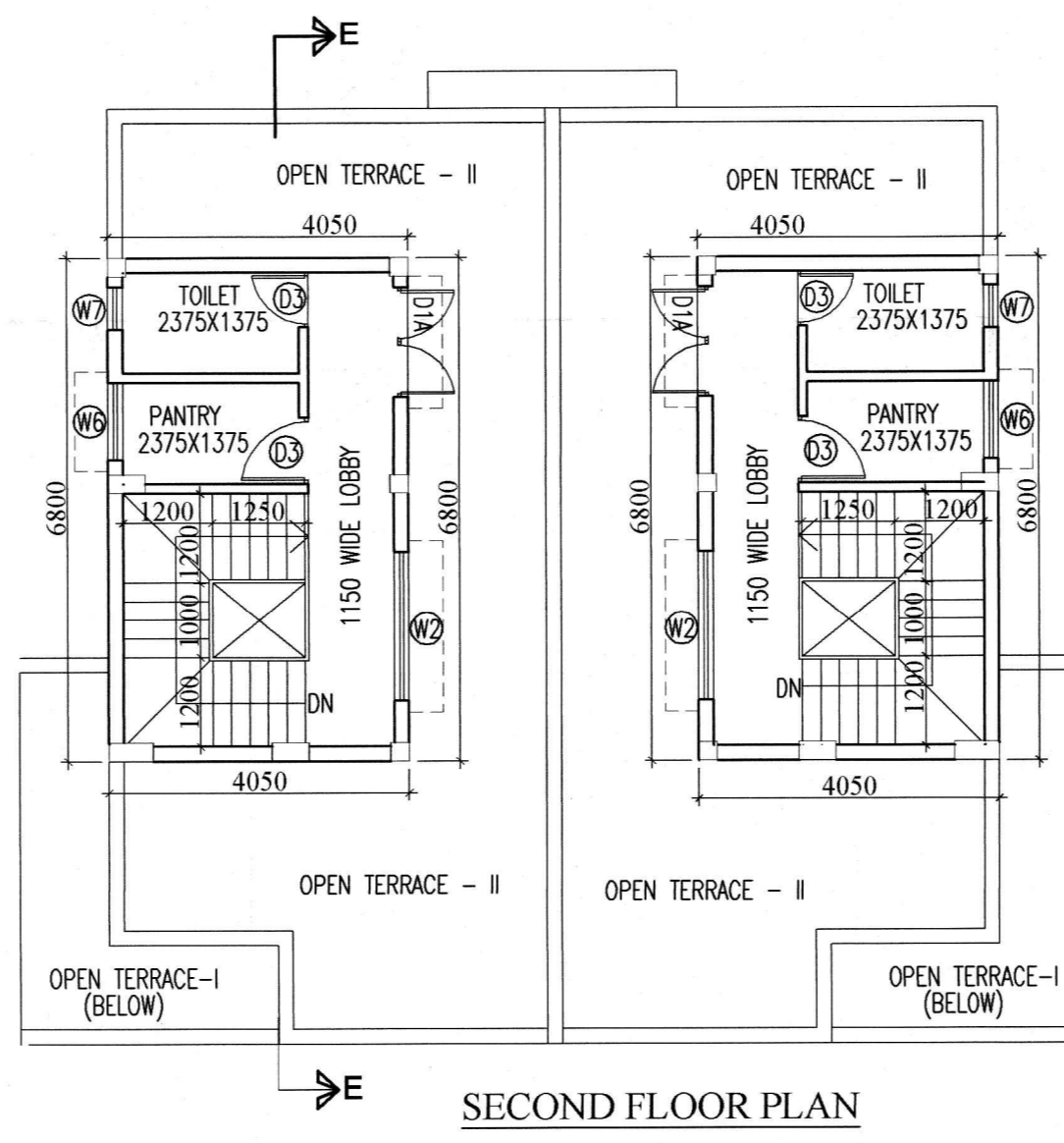
GROUND FLOOR PLAN



FIRST FLOOR PLAN



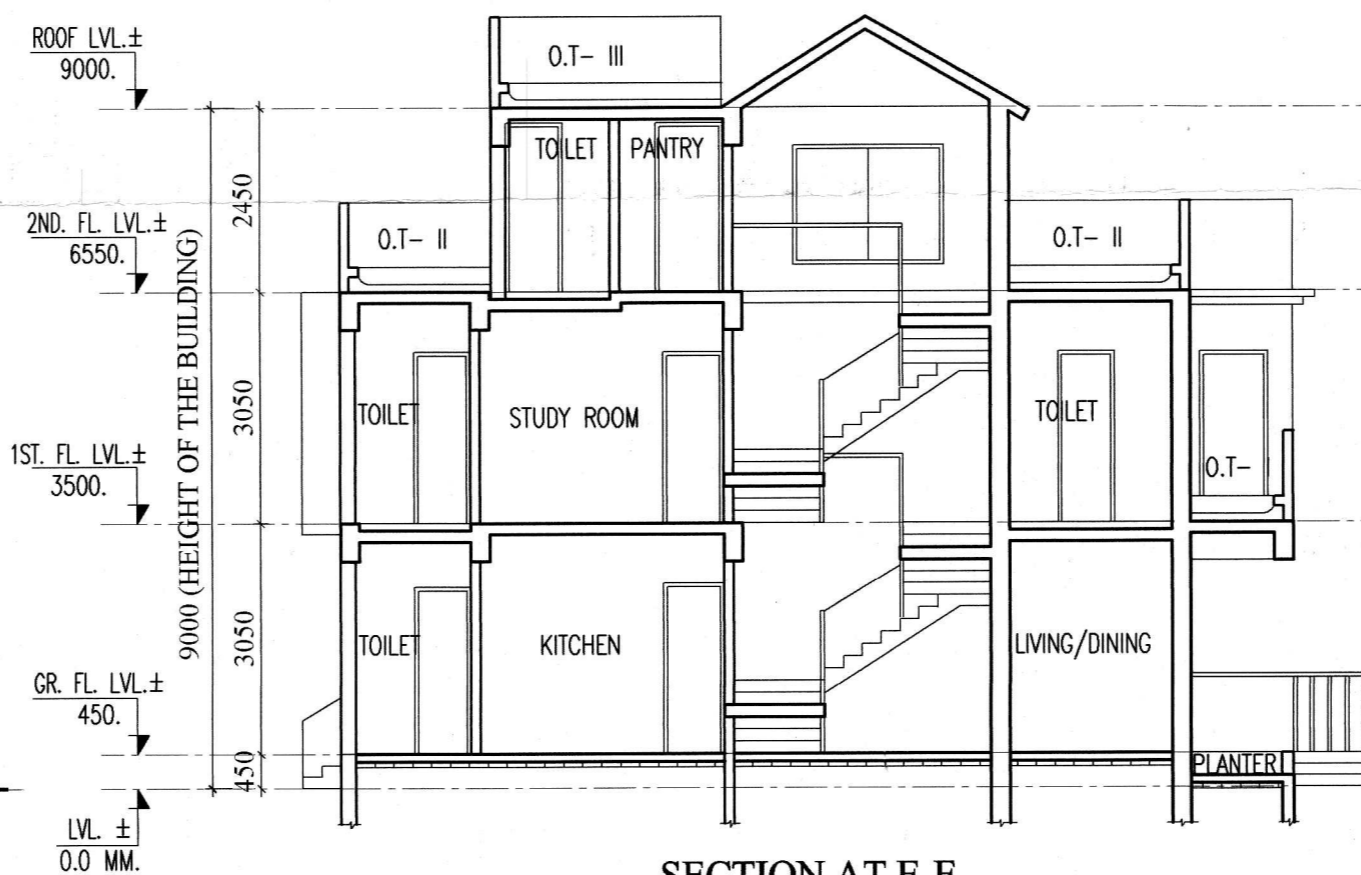
ROOF PLAN
