

Sir,

With reference to the subject captioned above, permission is hereby granted subject to the following conditions:

1. This permission / sanction is hereby accorded on the basis of the application submitted on 27/05/2022 and the notarised affidavit dated 3/05/23, with a proviso that the existing structure present over the piece of land as captioned above should be demolished with subsequent information in writing to the office of the undersigned and local Gram Panchayat regarding the start of work adhering to instant sanction. No modification of the existing structure will be allowed.
2. Departure from the above will make this sanction void and the authourity will remain compelled to initiate action as per provisions made in law.
3. Permission for construction of the structure/building is valid up to 02(two) years from the date of issuing the permission.
4. Permission of the structure/building is valid for occupancy of use of residential purpose.
5. The structure or building for which permission is granted shall have to be completed within 02(two) years.
6. The construction will be undertaken as per sanctioned plan only and no deviation from the sanction plan and from the provisions of GO No: 232/AD/PN/O/1/1A-07/2016 will be permitted.
7. For approach road permission from concerned road authority has to be taken.
8. Precaution should be taken during execution so that foundation of existing adjacent buildings is not affected in any way due to this construction.
9. Rules of other Govt. order either issued by state Govt. or central Govt. from time to time in this respect and which are in vogue should be abide by the land owner.
10. Two set of the site plan and the sanctioned building plan submitted along with the application is returned.
