WHEREAS after the partition of India a large number of residents of former East Pakisten crossed over and came to the territory of the State of West Bengal from time to time due to force of circumstances beyond their control.

AND whereas the Government of West Bengal (hereinafter referred to as the "Government") offered all reasonable facilities to such persons (hereinafter referred to as "Refugees") for residence in West Bengal.

AND whereas a considerable number of such people were compelled by circumstances to use vacant lands in the urban areas for homestead purposes.

AND whereas the DONEE was one of such persons who had come to use and occupy a piece of land particuarly described in the schodule herounder.

AND whereas the DONEE being a refugee displaced from East Pakistan (now Bangladesh) approached the Government of West Bengal for a plot of land for his rehabilitation.

AND whereas it has been decided by the Government to make a gift of the said plot of land in favour of the DONEE so as to confer absolute right title and interest in the said land where he has been residing peacefull for a long time more fully described in the schedule hereunder written.

NOW THIS DEED WITNESSETH that in consideration of the premises hereinbefore mentioned and t provide relief to the DONEE in consideration of his /her destitute condition the DONOR doth bereby absolute give grant and transfer unto the DONEE ALL THAT PIECE AND PARCEL OF LAND more fully describe in the schedule hereunder written as homestead land OR HOWSOEVER otherwise the said land hereditan en and premises are or is at any time or times heretofore were situated butted bounced as hereinafter describe TOGETHER WITH all ways, paths, passages, easements, privileges, appendages and appurtenance whatsoever with all easements whereto and therein TO HAVE AND TO HOLD THE SAID land hereditaments and premises hereby given granted and transferred unto and to the use of the DONE forever AND the DONEE shall and may at all times hereafter peacebly and quietly possess ar enjoy the said land hereby given granted and transferred subject to the condition that the DONEE shall have no right save as hareinafter provided to alienate or transfer in any way the land comprised in the schedule hereunder written in any manner whatsoever within a period of 10 (ten) years from the date these presents without obtaining prior written permission of the DONOR which shall not be obligatory the part of the DONOR to give and which will be granted only in exceptional circumstances of hardsh PROVIDED THAT THE DONEE shall be at liberty to mortgage, charge or encumber the said land wi the Life Insurance Corporation of India or any Nationalised or Scheduled Ban!: Co-operative Bank or Gover ment or any Statutory Body or Government Sponsored Financial Institution within this period of ten years i the purpose of construction of a residential building therein and for the purpose of better economic and physic improvement, AND THE DONOR and all persons lawfully and equitably claiming as aforesaid shall and w from time to time and at all times hereinafter at the request and costs of the DONEE do or execu or cause to be done and executed all such acts deeds and things whatsoever for further better and mo perfectly assuring the said messuage land hereditaments and premises and every part thereof unto t DONEE in the manner aforesaid as shall or may be reasonably required.
