  - If Form ITR-V is received beyond the 120<sup>th</sup> day of electronic transmission of the return data, then the day on which the return is e-verified or the Form ITR-V is received at Centralized Processing Centre, Income Tax Department, Bengaluru would be treated as the date of filing the Income Tax Return and all consequences of Income Tax Act, 1961, shall accordingly will be applicable.
