- 1. That Tarun Karmakar, Tanuj Karmakar, Mausaumi Bhattacharyya, Sabita Ray, Sourav Ray, Dhriti Kanta Roy, Kripadipti Ghoshal, Dipa Ganguly, Anindita Bhattacharjee, Arundhuti Roy @ Arundhuti Dutta and Sayari Ray have the legal title to the land on which the development of the proposed project is to be carried out and a legally valid authentication of title of such land along with an authenticated copy of the agreement between such owner and promoter for development of the real estate project is enclosed herewith.
- 2. That the said land is free from all encumbrances.
- 3. That the time period within which the project shall be completed by the promoter is 31^{st} December, 2026.
- 4.
