- 3. That the time period within which the project shall be completed by us is, within 31st March 2026.
- 4. That seventy percent of the amounts realised by us for the real estate project from the purchasers, from time to time, shall be deposited in a separate account to be maintained in a scheduled bank to cover the cost of construction and the land cost and shall be used only for that purpose.

- 8. That we shall take all the pending approvals on time, from the competent authorities.
- 9. That we have furnished such other documents as have been prescribed by the rules and regulations made under the Act.
- 10. That we shall not discriminate against any purchasers at the time of allotment of any Shops / Offices / apartment, plot or building, as the case may be, on any grounds.
