1. That BHASKAR SARKAR and SOUMI SARKAR have a legal title to the land on which the development of the proposed project at 41, Raja Basant Roy Road, Kolkata 700 029, PS Tollygunge is to be carried out and a legally valid authentication of title of such land along with an authenticated copy of the agreement between such owner (Bhaskar Sarkar and Soumi Sarkar) and promoter (Swastic Projects Pvt. That the Promoter shall get the accounts audited within six month after the end of every financial year by a chartered accountant in practice, and shall produce a statement of accounts duly certified and signed by such chartered accountant and it shall be verified during the audit that the amounts collected for a particular project have been utilised for the project and the withdrawal has been in compliance with the proportion to the percentage of completion of the project.

8. That Promoter shall take all the pending approval on time from the competent authorities.
