Be it mentioned here that Burdwan Municipal Authority has sanctioned a **G+V** storied residential building plan over the aforesaid property and on the basis of that sanctioned building plan issued by Burdwan Municipality, the party of the SECOND PART is constructing the **G+V** storied residential building over the schedule mentioned property.


