a) Advance Soil Work : Existing soil profile of proposed plantation area (vide approved plantation plan) is to be maintained. Planting pits of size 60 cm X 60 cm X 45 cm. are to be done and the dug up soil should be kept for proper weathering till planting. Depending on soil texture & conditions, filling of planting pits with good earth is to be done up to 45 cm. depth of subsoil. Fertility of soil is to be maintained by application of green-manure/manure.

b) Source of seeds & seedlings : From renowned Nursery to ensure tall tree-seedlings of good quality and performances with good height-collar girth ratio. Seedlings to be planted must be of minimum 1.5 years old.

c) Spacing & planting pattern

: Planting may be done along a line at 2.5 m. X 2.5 m.

d) Time schedule : Planting should invariably be done with the monsoon. If regular irrigation facility exists, planting can be done earlier also (to maintenance utilize the growing season fully) or later but not in winter unless unavoidable. Casualty replacement is to be done immediately as soon as noticed on regular monitoring of the tree-plantation. Weeding, cleaning to be done at 1 (one) month interval up to October. Further ¾ times up to July next year and to continue this schedule for the next 3 years. Mulching to be done considering soil texture of the area. For further improvement, maintenance, the Conservator of Forests/Research Circle, W. B. may be consulted.

e) Protection of seedlings : Protection of the planted tree-seedlings is to be ensured by providing Iron-Gabions which are to be renewed as and when necessary up to 3 years.

f) Period of Maintenance

: 5 years.

(b) Advance soil work.

Tree pit size is 60cm x 60cm x 60cm.

The loam soil will used for tree pit with mixing of cow dowang & Organic & inorganic manure.

(c) Source of seed & seedlings for plantation.

We are collecting seedlings from Forest Nursery, local nursery.

(d) Spacing & planting pattern.

2.5M spacing will maintain between two seedlings and it will be planted in a single row.

After obtaining Clearing Certificate we started plantation within eight month approx first week of June 2021. And maintenance will done upto three years by the Landscaping agencies.
