1. That the Firm has a legal title to the land on which the development of the on-going project is carried out by virtue of a Joint Development Agreement with (1) Sri Jayanta Ghosh(PAN:-ALMPG0122C) and M/s. **MAA BHABATARINI UDYOG**, a Partnership Firm under Indian Partnership Act, 1932(Act IX of 1932) having the PAN No. ABIFM5226D.

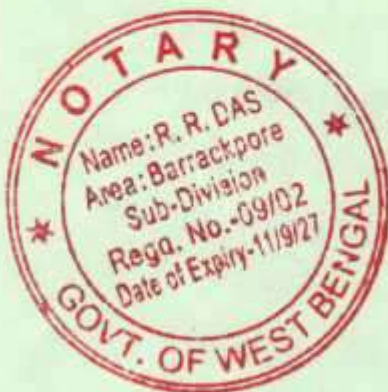
