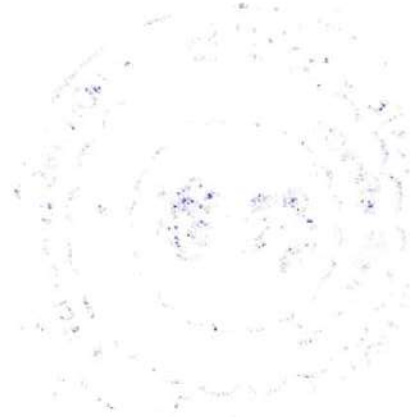

That my great Grandfather Bhudhur Chandra Ghosh after obtaining probate for the last will and testament of one Nettro Gopal Ghosh on 7<sup>th</sup> July 1906 from High Court of Judicature at Fort William in Bengal and being appointed as sole executor sold and conveyed to Ashutosh Dey all that brick built message tenament or dwelling house together with piece and parcel of free land containing by estimation 05 (Five) Cottahs 11 (Eleven) Chitacks and 26 (Twenty Six) Sq.Ft. little more or less along with right of common passage containing an area of 03(Three) Chitacks and 08 (Eight) Sq Ft being the back portion of the Premises No.17, Kambulia Tola Lane presently numbered as Premises NO.7B Kambulia Tola Lane, Kolkata - 700 005, P.S. Shyampukur, within the ward No.10 of the Kolkata Municipal Corporation vide an Indenture of Conveyance dated 10<sup>th</sup> day of September, 1909, being No.2338 for the year 1909, registered at Sub-Registrar, Calcutta.

That after the aforesaid sale to Ashutosh Dey said Bhudhur Chandra Ghosh my great Grandfather remained owner of all that brick built message tenament or dwelling house together with piece and parcel of free land containing by estimation 02 (Two) Cottahs 12 (Twelve) Chitacks and 32 (Thirty two) Sq.Ft. little more or less being the front portion of the Premises No.17, Kambulia Tola Lane, presently numbered as Premises NO.7A, Kambulia Tola Lane, Kolkata - 700 005, P.S. Shyampukur, within the ward No.10 of the Kolkata Municipal Corporation.

That said Ashutosh Dey by virtue of his last will and testament dated 12<sup>th</sup> day of December, 1912 duly registered at Registrar of Calcutta being No.83 for the year 1912 bequeathed in favour of my Grandfather Harit Kumar Ghosh son of Bhudhar Chandra Ghosh, all that brick built message tenament or dwelling house together with piece and parcel of free land containing by estimation 05 (Five) Cottahs 11 (Eleven) Chitacks and 26 (Twenty Six) Sq.Ft. along with right of common passage containing an area of 03(Three) Chitacks and 08 (Eight) Sq Ft being the back portion of Premises No.17, Kambulia Tola Lane in the town of Calcutta presently numbered as Premises NO.7B, Kambulia Tola Lane, Kolkata - 700 005, P.S. Shyampukur, within the ward No.10 of the Kolkata Municipal Corporation. The probate for the Will of Ashutosh Dey was granted on 29<sup>th</sup> day of May 1917 from High Court of Judicature at Fort William in Bengal.

That Bhudar Chandra Ghosh by his last will and testament dated 26<sup>th</sup> day of February 1961 bequeathed in favour of his grandson Shri Ashok Kumar Ghosh, son of Harit Kumar Ghosh, my Father all that brick built message tenament or

dwelling house together with piece and parcel of free land containing by estimation 02 (Two) Cottahs 12 (Twelve) Chitacks and 32 (Thirty two) Sq. Ft. more or less situated being the front portion of the Premises No.17, Kambulia Tola Lane presently numbered as Premises NO.7A, Kambulia Tola Lane, Kolkata - 700 005, P.S. Shyampukur, within the ward No.10 of the Kolkata Municipal Corporation.

That my father Ashok Kumar Ghosh on 15<sup>th</sup> day of September 1964 duly obtained probate from High Court at Calcutta in its Testamentary and Intestate Jurisdiction (126 of 1964) and was appointed as executor for the last will and testament of said Bhudar Chandra Ghosh.

That my Grandfather Harit Kumar Ghosh son of Bhudhar Chandra Ghosh became owner of Premises NO.7B, Kambulia Tola Lane, Kolkata - 700 005, P.S. Shyampukur, within the ward No.10 of the Kolkata Municipal Corporation.

That my father Ashok Kumar Ghosh, son of Harit Kumar Ghosh became owner of Premises NO.7A, Kambulia Tola Lane, Kolkata - 700 005, P.S. Shyampukur, within the ward No.10 of the Kolkata Municipal Corporation.


That my father Ashok Kumar Ghosh died intestate on 15.02.1973 leaving behind his wife Ashoka Ghosh (mother), two sons Alope Kumar Ghosh (elder brother), Kanak Kumar Ghosh (myself) and one daughter Baisakhi Ghosh (elder sister) as his legal heirs and successors as per laws of Hindu Succession. My mother Ashoka Ghosh wife of late Ashok Kumar Ghosh died intestate on 21<sup>st</sup> February, 2013.

That my Grandfather Harit Kumar Ghosh died intestate on 02.11.1977 leaving behind his wife SubarnaPrava Ghosh (my Grandmother), daughter in law Ashoka Ghosh, my mother (wife of Late Ashok Kumar Ghosh) and grand children Alope Kumar Ghosh (my elder brother), Kanak Kumar Ghosh (myself) and Baisakhi Ghosh (Kundu) (my elder sister) as his legal heirs and successors as per laws of Hindu Succession. My Grandmother Subarna Prava Ghosh wife of Harit Kumar Ghosh died intestate on 10<sup>th</sup> day of November 1979.

That upon death of Harit Kumar Ghosh my Grandfather and Ashok Kumar Ghosh my father by virtue of inheritance and Hindu law of succession Alope Kumar Ghosh, Kanak Kumar Ghosh and Baisakhi Ghosh (Kundu) all sons and daughter of Ashok Kumar Ghosh became joint owners each having respective

undivided 1/3<sup>rd</sup> share in Premises NO. 7A Kambulia Tola Lane, Kolkata - 700 005, P.S. Shyampukur being all that brick built messugetenament or dwelling house together with piece and parcel of free land containing by estimation 02 (Two) Cottahs 12 (Twelve) Chitacks and 32 (Thirty two) Sq.Ft and Premises NO.7B Kambulia Tola Lane, Kolkata - 700 005, P.S. Shyampukur being all that brick built message tenament or dwelling house together with piece and parcel of free land containing by estimation 05 (Five) Cottahs 11 (Eleven) Chitacks and 26 (Twenty Six) Sq.Ft. along with right of common passage containing an area of 03(Three) Chitacks and 08 (Eight) Sq Ft between both the premises.

That my sister Baisakhi Ghosh (Kundu) wife of Amar Krishna Kundu and daughter of Late Ashoke Kumar Ghosh died on 1<sup>st</sup> September, 2017 after publishing her last Will and Testament dated 22<sup>nd</sup> July 2017, being No.748 of 2017, registered at ARA III, Kolkata and recorded in Book-III, Volume No.1903-2017, Page from 10830 to 10844 whereby bequeathing her 1/3<sup>rd</sup> share in Premises No. 7A & 7B, Kambulia Tola Lane, Kolkata - 700 005 together with old dilapidated brick built message tenament or dwelling house standing thereon to her only son Amit Kumar Kundu.

That my nephew Amit Kumar Kundu the sole executor of the will made by Baisakhi Ghosh (Kundu) was duly granted Probate on 4th August, 2018 by the Court of Ld Chief Judge, City Civil Court, Calcutta in Probate Case No.70 of 2017 for the last Will and Testament of Baisakhi Ghosh (Kundu) dated 22<sup>nd</sup> July 2017, being No.748 of 2017, registered at ARA III, Kolkata.

That Aloke Kumar Ghosh (my elder brother), Kanak Kumar Ghosh (myself) and Amit Kumar Kundu (my nephew) have become joint owners each having respective undivided 1/3<sup>rd</sup> share in Premises NO. 7A Kambulia Tola Lane, Kolkata - 700 005, P.S. Shyampukur being all that brick built message tenament or dwelling house together with piece and parcel of free land containing by estimation 02 (Two) Cottahs 12 (Twelve) Chitacks and 32 (Thirty two) Sq.Ft and Premises NO.7B Kambulia Tola Lane, Kolkata - 700 005, P.S. Shyampukur being all that brick built message tenament or dwelling house together with piece and parcel of free land containing by estimation 05 (Five) Cottahs 11 (Eleven) Chitacks and 26 (Twenty Six) Sq.Ft. along with right of common passage containing an area of 03(Three) Chitacks and 08 (Eight) Sq Ft between

Shyampukur amalgamated said Premises No.7A, KambuliaTola Lane and Premises No.7B, KambuliaTola Lane the amalgamated Premises is renumbered in the records of Kolkata Municipal Corporation as 7A, KambuliaTola Lane, P.S. Shyampukur, Kolkata - 700 005 within the ward No.10 of the Kolkata Municipal Corporation and upon physical measurement found to be admeasuring 08 (Eight) Cottahs 11 (Eleven) Chittacks13 (Thirteen) Sq.ft more or less

That I along with my elder brother Alope Kumar Ghosh and my nephew Amit Kumar Kundu hereby declare that if any anomaly is found in the statements made above leading to any ambiguity or legal complications in future than the mutation granted in our name may be cancelled by concerned authority of Kolkata Municipal Corporation and as such the Kolkata Municipal Corporation shall be kept safe, harmless and indemnified by us as regards the mutation granted in favour of myself, Alope Kumar Ghosh and Amit Kumar Kundu for Premises NO.7A Kambulia Tola Lane, Kolkata - 700 005, P. S. Shyampukur.
