No.:-111, Mouza:- Tetikhola, P.S:- Newtownship, Dist.: - Paschim Bardhaman, West Bengal, Previously the approval towards construction of Building for (G+IV), i.e. within 15 meter was given by this office vide memo no. 412/PSBZP dated 24.02.22, Since the total height exceeds 15.00 mt. i.e. (G+VI) the application was sent to P & RD, Kolkata, vide this office memo no.: 715/PSBZP ct. 25.03.2022. The scheme has been cleared by P & RD vide their memo no.: 3580-RD-P/RIDF/IV-47/2022 dt. 15.06.2022.

As per resolution passed in the 10th Building Committee meeting & in pursuance of NOC No. 3580-RD-P/RIDE/IV-47/2022 dated 15.06.2022 of Deputy Secretary, P&RD Department, Government of West Bengal, "No objection" towards building construction up to (G+VI) may be given subjected to the following terms and conditions: -

- Height of the building should be maximum 20.15 cut, from Ground Level to terrace.
- 2. As certified by Smt, Jui Chatterjee, Architect, having License No. CA/2021/134352 & Susmita Choudhury, Structural Engineer having license no. CVER/NKDA/10/00175, Sri Asim Sarkar, Geotechnical Engineer having KMC Reg. no. GTE/CLASS-J/2 and votted by Prof. Dipankar Chakravorty of Civil Engineering Department, Jadavpur University, the Department of P & RD, Kolkata has intimated their "No Objection" in giving clearance of Building Plan vide their memo no. 3580-RD-P/RIDE/IV-47/2022 dt. 15.06.2022 (copy enclosed). This building plan, as certified, vetted & cleared by them shall supersede all other previous plans and shall always be strictly followed when building operations are in progress and such plan shall be made available for inspection whenever so required by any authorized representative or officer of the Jennus Gram Panchayat / Durgapur-Paridpor Panchayat Samity / Paschim Bardhaman Zilla Parishad, If as a result of inspection, it is found that the construction is not according to above plan, Panchayat/Panchayat Samity/Zilla Parishad will not be held responsible and reserves the right to take legal action against the developer.

As per resolution passed in the 10th Building Committee meeting presently "No objection" towards building construction upto (G+IV) may be given subject to following terms and conditions:-

1. All constructions have to strictly follow the relevant Panchayat Act / IS codes / National Building Codes, as wherever applicable.

2. The right, title and interest of applicant in respect of land on which the structure is proposed have been considered as certified by Prachan, Jemua Gram Panchayat.

The building shall not be constructed under or within the restricted distance of the Electric Power Supply line running on any side of the building site under provisions of the Indian Electricity Rules.

4. Necessary clearance for Fire, Environmental, Aviation and other Safety norms must be accorded from the Competent Authority.

- 5. Necessary permissions must be accorded from the Competent Authority to draw Ground Water during / after construction of the building
- Rain water harvesting along with recharging pits in sufficient numbers must be installed.
- Height of the building should be maximum 14.28 mt. from Ground Level to terrace.
- Necessary arrangement of Power Supply is to be made with due permissions from the Competent Authority.
- Proper adequate drainage facility by means of access and passage leading to existing public drains or drainage channels or by means of soak pit having adequate capacity is to be arranged with proper clearance from the competent authority.

Sanitary including garbage disposal facility is to be properly arranged by the applicant.

11. Provisions of S.T.P., if required, with necessary permission of the outfall from the competent authority is to be provided.

12. The building should have an approach road or passage for ingress or egress from or to a public road with necessary clearance from the

competent authority.

13. As certified by Ar. Jui Chatterjee, Architect, having Registration No.: CA/2021/134352, Susmita Choudhury, Structural Engineer having License No. ESE-I/RJPSON/130, ESR-II/KMC/664, STER/NKDA/21/00010, CVER/NKDA/10/00175, Asim Sarkar, Geotechnical Engineer having license no. GTE/CLASS-I/2 and vetted by Prof. Dipankar Chakravorty of Civil Engineering Department, Jadavpur University the proposed structure is safe and stable in all respect. This building plan, as certified by them, shall always be strictly followed when building operation are in progress and such plan shall be made available for inspection whenever so required by any authorisd representative or officer of the Jemua Gram Panchayat/Durgapur-Faridpur Panchayat Samity/ Paschim Bardhaman Zilla Parishad, during building construction. If as a result of inspection it is found that the construction is not according to above plan, Panchayat reserves the right to take legal action.

14. Not less than seven days before the commencement of work, a written notice shall be sent to Jemua Gram Panchayat, specifying the

dates on which the work is proposed to commence from.

Within one month from the date of completion of the construction of the building for which "No Objection" has been obtained, the owner of the building shall apply for obtaining completion certificate from Zilla Parishad through Gram Panchayat along with submission of "As Built" drawing, duly certified by originally entrusted Architect and Structural Engineers.

16. The plan remains valid for two years from the date of issue of no objection. If the construction work is not commenced / completed within the stipulated time, further application to be submitted before the concerned authority along with the deposition of necessary fees etc. as

per Zilla Parishad norms.

17. Amount to be realized from the developers as "No objection fees" amounting to Rs. 5,07,611/- for Covered area of 20304.45 S.ft. @ 25/per Sit. After which 70% of the above amount i.e. Rs. 3,55,328/- is to be deposited in favour of Paschim Bardhaman Zilla Parishad, payable at Asansol through Bank Draft within 15 (fifteen) working days otherwise this NOC will be cancelled from ZP end.
