2. That the said land is free from all encumbrances
3. That the time period within which the project shall be completed by Promoter is 03-10-2025.

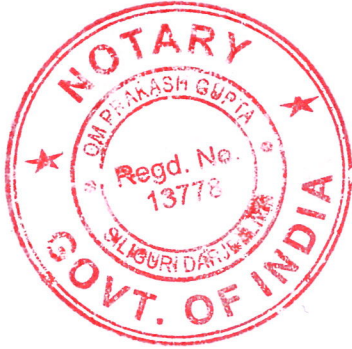
7. That Promoter shall take all the pending approvals on time, from the competent authorities.
