WHEREAS the parties herein have decided to start on the business as **Civil Contractor, Promoting and Development** under the name and style of '**MAA TARA ASSOCIATES**' in the form of partnership firm having its office at 465, School Road, Dhamaitala, P.O.- Dakshin Jagaddal, P.S.-Sonarpur, Dist.- South 24 Parganas, Kolkata – 700151, West Bengal.

AND WHEREAS the parties herein deem it proper to record all the terms and conditions on which they have agreed to the aforesaid business and/or any other business as may be decided by the partners from time to time in partnership w.e.f. 23th day of may , 2022 to writing by means of deed of partnership under certain terms and conditions mentioned hereunder.

NOW THIS INDENTURE WITNESSETH AND IT IS HEREBY AGREED AND DECLARED BY THE ABOVE NAMED PARTNERS AS FOLLOWS:-

- 1. NAME AND ADDRESS OF THE FIRM :-** That the parties hereto shall at present constitute and became partners of the firm under the trade name and style of '**MAA TARA ASSOCIATES**' in the form of partnership firm at 465, School Road, Dhamaitala, P.O.- Dakshin Jagaddal, P.S.- Sonarpur, Dist.- South 24 Parganas, Kolkata – 700151, West Bengal from its principle place or places at mutually decided and agreed upon by the partners herein in accordance at their will.

- 2. COMMENCEMENT AND DURATION :-** The business of the partnership firm shall be deemed to have COMMENCED on and effect from 23th day of may , 2022 and this partnership shall be at will and will continue so long as the partners may desire.
- 3. OBJECT OF THE BUSINESS :-** The main object of the partnership business will be **Civil Contractor, Promoting and Development work**. But the partners shall have the option to embark upon any new line of business and open & close branches and all the terms and conditions of the partnership shall apply to them.
- 4. CAPITAL :-** That the total capital of the business as on 23th day may, 2022 is Rs. 30,00,000/- (Thirty Lacs) only. This total capital would be equally shared within the all partners Rs. 500,000/- (Fifty Thousand) only each and this capital is deemed to be invested by all the partners to constitute the firm as initial capital. Any further capital require by the firm may contribute by the partners in terms of advance bearing interest @ 12% p.a.
- 5. INTEREST ON CAPITAL :-** That the partners of the said partnership firm hereto shall contribute any amount into the business if required in future in that event, said amount shall be treated as loan and shall pay interest @ 12% per annum unless otherwise mutually decided upon by the partners hereto .
- 6. SALARY TO PARTNERS :-** That may be paid any salary,bonus, commission or remuneration, by whatever named called as decided upon by them mutually. However the aggregate amount paid to all the partners taken together shall not exceed amount which will be allowed in the computation of the Firm's income as per the provisions of the Income Tax Act 1961.
- 7. PROFIT & LOSS SHARING RATIO :-** That after maintenance of office, payment of staff /staffs for every month, rent of the office rooms and electric bill etc. and all miscellaneous expenses of the said business and charging interest on capital and salary of the partners, the balance of profit of the firm should be divided as per ratio of 1st Part – 18%, 2nd Part – 18%, 3rd Part – 16%, 4th Part – 16%, 5th Part – 16% and 6th Part - 16% amongst the partners of the firm. Similarly if there is any loss that would be borne by the partners in same ratio.
- 8. DRAWINGS :-** The partners shall not draw any amount from the capital contributed by them as aforesaid except with prior consent of the other partner but the partners shall free to draw from their respective share of profits if any, which shall be credited to their respective personal accounts on the taking of annual accounts of business of the firm .
- 9. BANK ACCOUNTS :-** That the partners of the firm will maintain Banking account /accounts in the name of the 'MAA TARA ASSOCIATES' in any reputed schedule bank(s) in the district and in any other place for the facility of the said business. The banking account/accounts shall be operated by the **RABISANKAR DEBNATH (Partner of the FIRST PART)**,

CHANCHAL DAS (Partner of the FOURTH PART) and BUNTY DAS (Partner of the FIFTH PART) jointly whenever necessary. All moneys and securities for money belonging to the partnership (except moneys required for current expenses) shall be paid into the deposited with schedule banks or bankers as the partners shall from time to time determined. Cheques drawn on partnership accounts shall be signed by the **RABISANKAR DEBNATH (Partner of the FIRST PART), CHANCHAL DAS (Partner of the FOURTH PART) and BUNTY DAS (Partner of the FIFTH PART)**.

10.ACCOUNTING YEAR :- That the accounts of the said firm shall be closed on 31st March of every English Calendar year . All the partners shall sign the final accounts. And on account of the partnership agency shall be taken every month or at times of the partners will determine.

11.ACCOUNTS :- The account shall regularly maintain, in the ordinary course of business, a true and correct account of all its incomings and outgoings and also of all assets and liabilities, in proper books of accounts, which shall ordinarily be kept at the place of the business and an account shall be taken once in every year as on 31st day of the month of March of the Profits and Losses of the business carried on by the firm and a balance sheet prepared on the firm assets and liabilities as on that date which shall be signed by the partners and a copy of each shall be supplied to each partner. Every partner shall have the right to access the books and verify their correctness.

12.DUTIES OF EVERY PARTNERS :-

- a. That every partner of said firm shall be JUST AND FAITHFUL to the other partners in all transactions and matters relating to the said business.
- b. That the proper account should be maintained under the responsibility of all the partners of the said firm and all the bill, voucher, challan etc. should properly be preserved and be kept in the office. None of the partners would be allowed to take any papers, books of accounts outside the office without the consent of the other partner.
- c. Every partner shall attend diligently to the business of the partnership firm and carry on the same for the greatest advantage of the other.
- d. That every partner shall all time give to the other partner just and faithful accounts of all matters, relating to the partnership business and upon every request furnish a full and correct explanation thereof to the other partner.
- e. That each partner shall devote responsible time, energy and attention to the business of the partnership firm.

- f. That all notices required to be given to the partners hereunder, shall be deemed to be duly served, if addressed to such partner or partners at the place of business of partnership and sent through registered post.
- g. That all or any of the terms and conditions at this deed may be MODIFIED, ALTERED OR VARIED AND ANY NEW TERMS AND CONDITIONS MAY BE ADDED TO by the mutual consent of the parties hereto, to be expressed in writing or implied from conduct.












13. RETIREMENT :-

- a. That any partner wants to retire from this partnership business, the partner should give at least 90 days clear written notice to the other partner and after receiving the said notice shall arrange the payment of intending partner and thus the partner give opportunity to go outside of the partnership business.
- b. That retirement of insolvency of any partner shall not have been the effect of dissolving the partnership and the share of such retiring partner of the firm.
- c. That none of the partners is entitled to transfer his share in any way to any third party except the other partner.
- d. Upon the dissolution of the firm either by death of a partner or by notice the other partner may purchase his shares in the effects at a valuation to be made by other partner as therein after mentioned.



