- I, Mr. Samir Kumar Roy of M/s. Divine Construction, promoter of the proposed project / duly authorized by the promoter of the proposed project do hereby solemnly declare, undertake and state as under:
- That the Firm has a legal title to the land on which the development of the ongoing project is carried out by virtue of a Title Deed in the name of M/s. Pratham Construction, a Partnership Firm under Indian Partnership Act, 1932(Act IX of 1932).

AND

All legally valid authentications of title of such land along with an authenticated copy of the Agreement between such owners and the Partnership Firm for development of the real estate project are enclosed herewith.

- 2. That the said land is free from all encumbrances.
- That the time period within which the project shall be completed by the Partnership Firm within the date of 30/06/2026 which is 34 (Thirty Four) months from the date of signing the 1st. Sale Agreement.
- 4. That seventy per cent of the amounts realised by the Partnership Firm for the authorized estate project from the allottees (per proforma agreement for sale), from time shall be deposited in a separate account to be maintained in a scheduled possible to cover the cost of construction and the land cost and shall be used only for that purpose.
