



JOYASRI GHOSH (PAN ACIPG6102F), widow of Late Asit Kumar Ghosh, by faith Hindu, by occupation Housewife, residing at Dutta Tower, Flat No.4C, 5th Floor, Park Market, Hirapur, P.O.CMPF, P.S: Dhanbad Town, Dhanbad- 826001, Jharkhand, all by faith Hindu, do hereby jointly and severally, solemnly declare, affirm and state on oath as follows:-
- i. That one Asim Kumar Ghosh, Ajit Kumar Ghosh, Smt. - d. In Page No. 11, Line Nos. 18 and 19 from the top under paragraph No. 21, it has been mentioned that 2.5899 Cottahs, equivalent to 4.2733 Decimals comprised in R.S. Dag No. 996/1481 now L.R. Dag Nos. 2445. It is stated that area has wrongly been inserted. The correct area should be 0.2543 Cottah equivalent to 0.42 Decimal and accordingly it should be read as 0.2543 Cottah equivalent to 0.42 Decimal in place and stead of 2.5899 Cottahs, equivalent to 4.2733 Decimals.
- e. In Page No. 16, line No. 3 and 4 from the top under the heading Second Schedule, it has been mentioned that 0.0065 Cottahs, equivalent to 0.0107 Decimals comprised in R.S. Dag No. 996/1479 now L.R. Dag Nos. 2441. It is stated that area has wrongly been inserted. The correct area should be 2.3495 Cottah equivalent to 3.88 Decimal and accordingly it should be read as .3495 Cottah equivalent to 3.88 Decimal in place and stead of 0.0065 Cottahs, equivalent to 0.0107 Decimals.
- f. In Page No. 16, line No. 6 and 7 from the top under the heading Second Schedule, it has been mentioned that 2.5899 Cottahs, equivalent to 4.2733 Decimals

- ix. It is declared that the errors and omissions occurred as mentioned hereinabove are merely inadvertent mistakes and does not affect title and area of the land which has already been transferred by the said Deed.
