1) NAME AND PLACE:-

3) COMMENCEMENT AND DURATION:-

That the Partnership constituted between the Parties hereto as Partners in the business hereinafter described shall be deemed to have commence on the 01st day of May, 2022 and the Parties hereto is and shall be Partners in the said business from that day and in the shares and under the terms and conditions

That this is a 'Partnership at Will' and shall continue until determined under the provisions of the Indian Partnership Act 1932 subject to the provision hereinafter expressed.

4) CAPITAL AND INTREST:-

That the necessary capital as well as further funds required for the purpose for the Partnership business shall be contributed by the Partners in such manner as may be mutually agreed upon by and between the Partners from time to time and the amount so contributed towards capital shall carry interest at the rate of 12% p.a. or as decided by the Partners from time to time but in no case shall exceed the maximum rates what has been prescribed in the Income Tax Act, 1961 under Section 40 (b) thereof from time to time. However in case of loss or lower income rate of interest can be nil or may be agreed to between the Partners.

RENUMERATION:-

The total remuneration payable to the working partners shall be worked out as

- (a) On the first Rs 3,00,000 of book profit or in case of loss @ 90% of book profit or Rs 1,50,000 whichever is more.
- (b) On the balance of book profit @ 60% of the book profit.
- For the purpose of this clause the expression 'Book Profit' shall mean the Book Profits as defined in section 40 (b) of the Income Tax Act, 1961, or any statutory modification or re-enactment thereof, for the time being enforce.

6) WITHDRAWLS:-

12) EXPULSION:-

- b) Commit any act of insolvency or
- Become physically or mentally unfit to attend to the business of the Partnership or
- d) Do or suffer any act which can be a ground for dissolution of the Partnership by the Court,

then and in any such case, the other Partner/s may after mutual consent may by notice in writing expel such Partner/s from the Partnership forthwith.

OF remaining Partner/s shall take over his/ her share in proportion to his/her interest in the firm or may admit a new Partner and pay the expulled Partner his/her capital/ profits/ interest if any till that date.

13) RETIREMENT AND DEATH:-
