
I hereby revoke all <u>WILLS AND TESTAMENTARY DISPOSITION</u> if any, heretofore made by me previously or any other **

I state that my family consists of myself, my wife Smt. Gita Bhur and two sons Sri Debasish Bhur and Sri Subhashis Bhur and no daughter.


I say that my said two sons are married and well placed and settled in their respective lives. .


