

Tapan Das, by occupation Service, by Nationality Indian, by faith Hindu, residing at 6, Jiban Krishna Mitra Road, P.O. Belgachia, P.S. Chitpur, Kolkata-700037 hereinafter jointly referred and called as DONEE (which expression shall unless exclude by or repugnant to the context be deemed to mean and include their respective heirs, successors, administrators, assigns, legal representatives) of the OTHER PART.

WHEREAS one Smt. 


