That I/Promoter shall get the accounts audited within six month after the end of every financial year by a chartered accountant in practice, and shall produce a statement of accounts duly certified and signed by such chartered accountant and it shall be verified during the audit that the amounts collected for a particular project have been utilized for the project and the withdrawal has been in compliance with the proportion to the percentage of completion of the project.

8. That A Promoter shall take all the pending approvals on time, form the competent authorities.

That I/ promoter have/has furnished such other documents as have been prescribed by the rules and regulations made under the Act.
