

In accordance with the search done 2009 it was found out that the predecessor of Ortem Credit Private limited that is Jamuna Sarkar and Pronati Bhattacharya were lawful owner of said property admeasuring 7 cottahs 8 chittacks 0 Sq.Ft. which comprised in L.R. Dag No 111 & corresponding to R. S. Dag No. 107, in along with R.S. Khatian 188 and L.R. Khatian Nos. 2798 and 2799, of Mouza- Dhelua, J.L. No. 43, R.S. No. 235, Ward No. 2 within jurisdiction of the sub Registrar of Sonarpur, under P.S. Sonarpur, District 24 Parganas (South) at Rajpur-Sonarpur Municipality.

We have inspected all the original Sale deeds as mentioned above.

1. We have caused to have search made out in the office of the A.R.A. I for 18 years through search clerk, Mr. D.D. Bhattacharya. In terms of the records maintained by the registration office and the report which has been given to us by the search clerk, we have found the following four entries in respect of R.S.Dag No.107 & R.S. Dag No 108 in the search in the records of A.R.A. I at Kolkata, following information were found out:-

From the certified copy it was observed by Indenture dated 7th August, 2008 executed by the Shaymal Dutta and Anita Dutta therein referred to as Vendors and Basudeb Dutta therein referred to as Vendee, the Vendor therein had sold, transferred, conveyed, granted, assigned and/or assured on to the Vendee therein all that piece and parcel of land measuring 5 Cottahs being R.S. Dag No-107 comprising in L.R. Khaitan-188, JL-43, RS-235 upon enquiring we had been certified not the same portion relates to the dag no situated on the other side of the land.
