(Terms and Conditions for conversion)

- a) This permission for conversion is without prejudice to any of the provisions of Chapter - IIB of the W.B.L.R. Act., 1955.
- b) This permission of conversion is also without prejudice to any of the provision of Urban Land (Ceiling & Regulation), Act., 1976 (Sec.33 of 1976) & of town & country (Planning & Development), Act., 1979 if these are applicable to the lands involved
- c) This permission for conversion will stand revoked if there is any violation of any of the provisions of prevailing laws enforcing prevention of environmental pollution effecting public health in general of the locality at any point of time.
- d) This permission for conversion will also be stand revoked if the land is used other than the purpose for which permission is given.
- e) The rent shall be realised at double the rate of rent payable immediately prior to such conversion. The rent so determined will be subject to future adjustment against revenue as may be determined under the provisions of any subsequent Acts and Rules.
