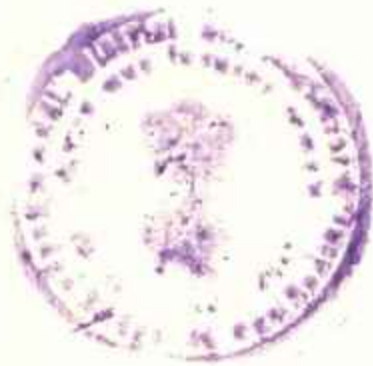

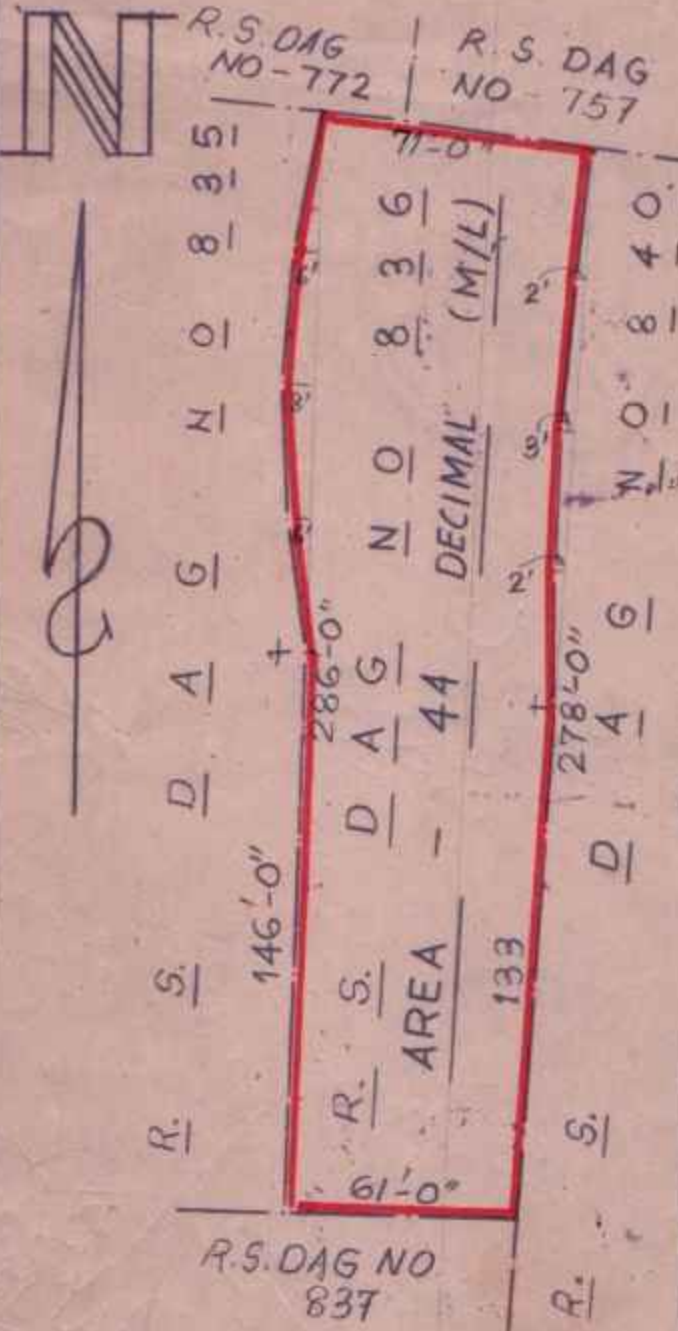
BASIS ON MAP, SITE PLAN OF LAND
