7.2.3 By an Indenture of Conveyance dated 6th April, 1939, registered with the District Registrar of Alipore in Book No. I, Volume No. 42, Pages 175 to 181, Being No. 1224, for the Year 1939, the said Godfrey Fredrick Clayden sold transferred and conveyed the Original Premises to and in favour of one Mugneeram Bangur & Company, a registered partnership firm.

7.2.4 The said Mugneeram Bangur & Company carved out various plots with roads, passages etc. within the Original Premises.
